

To Whom It May Concern:

I would like to report a U.F.O. sighting which took place on Saturday, Nov. 21, 1970 at 9:50 p.m. (E.S.T.). I was located at Commack, Long Island in my backyard, when the sighting took place.

The objects looked like faint stars, they moved in a straight line from north to south. They were in two rows and moved in a uniform pattern which I have drawn below.



I viewed the objects for approximately 2 or 3 seconds before they disappeared. Their altitude above the horizon was about 60° or 70° degrees. They appeared between the constellations Orion

and the Square of Pegasus. The sky was very clear and no clouds were in sight. They appeared to be traveling at a very high altitude and were moving quite fast.

I would like to know if there were any other reports concerning this specific sighting. Thank You.

NORAD CONTRIBUTES TO
DEFENSE PLUS ECONOMY

Picture yourself holding a huge umbrella over the vastness of the United States and Canada; an umbrella that protects this great nation from attack by bomb-carrying planes and air-breathing missiles. This is the picture of NORAD: The North American Air Defense Command with headquarter facilities carved out of ~~a huge mountain in~~ Cheyenne, ~~near~~ Wyoming, ~~in~~ Colorado Springs, Colo.

Here in the northeast, including the New England states (except for the northern half of Maine), part of Pennsylvania, and New York State, our skies overhead are protected by the 21ST NORAD REGION.

X Commanded by ^{Air Force} Major General George V. Williams, 21ST's headquarters offices are located in the massive SAGE building at Hancock Airport,

X in Syracuse, and are staffed by U.S. Air Force, Army, Navy and Canadian military personnel.

X General Williams is also commander of 31 units in the 21ST Air Division.^{The 21st is U.S. Air Force's contribution to NORAD.} Wearing his air division hat, the General's mission is to command, administer, train, equip, and generally prepare for their performance air force units located in the northeastern part of the United States, some radar squadrons in Canada, air bases in Greenland, and a fighter squadron plus radar squadrons in Iceland.

In addition, this air division commander also has operational responsibility for some air national guard units to insure they are properly trained and that their maintenance procedures are in accordance with air force standards.

Wearing his division hat, General Williams provides the aforementioned units to other operational commanders for the purpose of providing defense. He provides the units within the northeast to himself because, wearing his second hat, he is NORAD REGION commander for the northeast.

Of note, the General also provides a fighter squadron and radar squadrons at the tip of northern Maine and also in Canada to the 22ND NORAD REGION located at North Bay, Ontario. This region has a command post similar to SAGE in Syracuse only with a Canadian in command.

X In their operational capacity, these units perform their air defense role under the Canadian leader. They report to him. And respond to him. In addition, the General also provides ^{one} ~~two~~ fighter squadrons and ^{two} ~~6~~ radar squadrons to a Navy commander who is charged with the operational mission ^{FIGHTING} (in the battle, so to speak).

General Williams, in terms of his division hat, tends to think of himself as "administrator, housekeeper, doctor, judge, and janitor." However, when a division unit goes into battle, it operates under its operational commander.

Should there ever be an enemy air attack in the northeast, it would be the mission of the 21ST NORAD REGION, under General Williams, to provide the air defense for this area. He would have at his disposal air force units plus several army and navy commands.

~~X~~ For example, ground-to-air ~~Bomarc~~^{NIKE} missiles protect Boston and New York. Though these army units are under the command of an Army commander in peace time, during an actual battle General Williams would command the forces from SAGE in Syracuse.

The heart of the SAGE (semi-automatic ground environment) system is a computerized system into which are electronically tied all of the air defense units in the NORAD region. Compilation of data is fed into the computer from the multitude of radar squadrons, providing an air picture for the scopes at SAGE.

~~X~~ According to Captain James Shirey, ^{An} Intercept Director, "Because our radar squadrons are located on the borders of our NORAD region, we can see well beyond our geographic region. In fact, we can survey many, many thousands of square miles of sky.

"Using the data presented on the scopes and in the computer, we can detect incoming targets, identify them, conduct intercepts, determine whether these are friendly or hostile, and take whatever tactical action is appropriate.

"We have here a capability of seeing tracks when they first come into our region through our surveillance section. Coupled with this is the identification section which identified ~~our~~ aircraft as friendly, unknown, or hostile. These two sections put their data into the computer which feeds it to the weapons section, the third section.

"We also have a manual input system which is responsible for inserting into the computer other information as, for example, weather information and flight plans, received from New York, Boston, Montreal, and Toronto. This additional data is a help to the weapons section in conducting its intercepts and completing missions."

Training is continuous in the 21ST NORAD REGION, as is the ~~Regions~~ ^{ALL} ~~Units~~ case with ~~other~~ North American Air Defense Commands located throughout the United States and Canada. At SAGE in Syracuse the weapons section, on a daily basis, ^{Controls jet fighters on} ~~flies~~ intercept missions and sends fighter squadrons on daily training flights to help pilots become more proficient with their aircraft.

In the event SAGE is destroyed, two back-up computer centers, located at isolated points, can together pick up the air battle. Should these also be put out of operation, the radar squadrons can send their data directly to the NORAD center computers located within Cheyenne Mountain.

Too, in the event data lines feeding information from the radar squadrons to the computer were either destroyed or damaged, there exists an elaborate arrangement which allows communications to flow through a countless number of different routes to get from point to point.

Sophisticated switching centers are located in fairly isolated areas. And there are many of them. In fact, according to SAGE authorities, the communications system of the 21ST NORAD REGION is probably the most redundant and survivable part of the entire complex.

SAGE also maintains its own power plant, and a very large one indeed, twenty-four hours a day. Though a great deal of commercial power is used, wherever this is the case a back-up system exists. Thus, the SAGE power plant can operate on its own in the event commercial power resources either are destroyed or power production falls low.

A word about the individual squadrons. At each radar squadron is a large search radar which is capable of detecting aircraft at altitudes from quite low to very high. This radar rotates through a 360 degree cycle and searches the entire area of sky within its range.

Co-located with the search radar is a height-finder radar which is capable of determining exactly how high an object is after its detection by the search radar. Though the search radar defines an object longitudinally and latitudinally, in order to run an intercept, it is necessary for the height-finding radar to determine whether the aircraft is, say, at five or fifty-thousand feet.

Too, at each site is a series of radio transmitters through which ground-control operators either talk to the interceptor pilots or send coded electronic instructions to unmanned missiles which can be guided electronically from the ground to the target. These transmitters are also tied to the SAGE computer and the two subordinate computers. This allows the weapons controller to control both interceptors and missiles electronically anywhere within the 21ST NORAD REGION area.

Explains Captin Shirey, "We can either control an interceptor or let the computer control it entirely. Through the SAGE computer we can send coded electronic information to the aircraft, telling it how to steer, what altitude to fly to, and what course to fly. We can also tell the computer whether we want the aircraft to attack from the rear, the side, or the front. This is all accomplished by a coded message to the computer receiver aboard the aircraft.

"The pilot in the interceptor aircraft then has a choice. On the one hand, he can fly the plane manually, following the displays our instructions generate on his radar scope: The computer generates a dot in the center of the scope. If the pilot keeps the dot in the center of the radar scope, it will steer him to the target.

"On the other hand, he can turn his plane to automatic control, take his hands and feet off the controls, and watch as the aircraft, guided by the computer, automatically takes him to the target. All he has to do is move the throttle to reach the speed the computer indicates and squeeze the trigger when told to by the computer."

X Active fighter squadrons^{in New York} are maintained primarily at Griffiss^{AFB} Air Force Base and Niagara^(IAP, and OIS Air Force Base in Massachusetts) Air Force Base. With radar squadrons located at Lockport, Watertown, Saratoga Springs, and Montauk, on the extreme tip of Long Island.

Consider, for example, the 48th Fighter Interceptor Squadron located at Griffis^{AFB}, near Rome. This squadron comprises twenty F106 fighter planes, twenty-four pilots, and 470 support personnel devoted to keeping the planes flying.

"All of the pilots of the 49th have flown combat missions over Vietnam and Laos," notes Captain "Goose" Gowell, 49th FIS Information Officer. "This is also true of the ~~seven~~ other active and ^{dis National} guard squadrons located within the 21ST NORAD REGION."

Though the F106, flown by the 49th, is primarily an interceptor aircraft, it is also a superb plane for aerial combat against other fighters and compares favorably with other fighter planes flown. Too, because this plane can refuel in flight, it is capable of service anywhere in the world as both interceptor and aerial combat plane.

The 49th squadron is constantly at top training. In the event of enemy attack, its planes can be airborne immediately. Under peace time conditions, fifteen minutes is the maximum time in which planes become airborne during a practice alert. However, under battle conditions, all planes must be in the air, and can be, within five minutes.

The SAGE computer keeps track of all these interceptor planes plus other large aircraft (excluding the small private planes), especially those approaching the northeast from the eastern Atlantic. When the SAGE personnel decide to track an aircraft, they put a computer tag on it, and the computer generates information on the speed, heading, and altitude.

This is done for training and, not too infrequently, when a plane is of special interest. As, for example, when ^aflight either is hijacked or is carrying the president or some other very important person. Naturally, any plane which is considered a possible enemy aircraft is followed with tremendous care.

Actually, SAGE tracks many so-called iron curtain country commercial aircraft that are on authorized flight plans. Not too infrequently, these commercial flights stray off their flight plan because of navigation errors. Should a plane be an unknown, it is labeled as such. If the plane is not a friendly by any of the available data, an interceptor is sent to check it just as soon as the aircraft comes under SAGE surveillance.

More specifically, when SAGE picks-up on its radar scopes an aircraft in the seaward area where identification must be made, it has only two minutes to identify him as either friendly or unknown. At the close of that two minutes, if the plane has not been identified as a friendly, SAGE scrambles a fighter.

A preplanned procedure is followed to determine the aircraft's purpose. It's the mission of the interceptor to look at the plane and identify its type, markings, and number. To date, all unknowns checked by the 21St interceptors have been commercial airlines and identifiable as such.

Throughout the 21ST NORAD REGION there is great emphasis on safety, including ground safety, flight safety, and missile safety. A Chief of Safety with a staff of six safety personnel, all of them well trained by the Air Force and in civilian universities, is headquartered at SAGE.

These men consider their prime duty to be the eyes and ears of the commander. They spend sixty percent of their time visiting the units with the hope of spotting a potential hazard and eliminating it before an accident occurs.

The Air Force's basic philosophy of safety is that all accidents are preventable and that the only acceptable rate of accidents is the zero rate. At this writing, ^{THE 21ST DIVISION} SAGE holds one of the highest safety records in the Aerospace Defense Command: 4.5 accidents per 100,000 flying hours. This is considered a ~~high~~ ^{low} rate for the type of military aircraft flown.

Each fighter squadron is assigned a flight surgeon who is well trained in aviation medicine. He keeps a close eye on the pilots to insure there is no problem that could cause a hazardous situation during a military mission. In the event a condition arises which could possibly incapacitate a pilot, he is grounded either temporarily or permanently.

Should there be a flight accident, a nine-man accident investigation board, including advisors to the board, is immediately sent to the accident scene. Ground accidents are also investigated by safety personnel who have been taught investigation procedures. All accidents, of whatever type, are reported not only to SAGE but also to the Aerospace Defense Command.

Of note, two major unions represent the employees working at Hancock Field. These include The Service Employee International Union, local 200 and The National Association of Government Employees, local R246.

In addition, Western Union employees are represented by the United Telegraph Workers, local 42, and AT&T employees by the Communication Workers of America. Both AT&T and Western Union work on a contract basis with the government, and their employees work full time at SAGE.

The base commander and the union representatives confer quarterly to discuss mutual problems and to resolve them. In addition, the civilian personnel officer meets with the union representatives monthly to review daily problems which have arisen since the previous month's meeting. Too, through an open door policy, union representatives report infractions as these occur and before they become problematic.

"The result of union representation has been to improve working conditions," maintains Rose M. Della Valle, of the Chief Employee Management Development Branch of the Central Civilian Personnel Office. "I find we are inclined to accept matters as they stand until someone brings problems not previously recognized to the fore."

Adds Lloyd Olszewski, Divisional President for Local 200 of The Service Employee International Union, "We've developed a pleasant relationship with management representatives and have been able to discuss difficult matters freely and informally. The greatest benefit of all, however, is the fact we can talk to management. This has been made possible by the recent Presidential Orders which give federal employees the right to organize."

Obviously, the 21ST NORAD REGION contributes not only to the air defense of the northeast but also to its economic betterment. Some five-hundred plus employees alone are employed at SAGE, at high paying, highly skilled positions. In addition, the 21ST spends millions of dollars annually purchasing many of its product needs from local retail firms.

Too, as is the case throughout the Air Force, the 21ST serves as a virtual job training center. Many a young man, having completed his military obligation, has entered industry as a skilled computer technician.

"In my opinion, the SAGE computer gave a tremendous boost to the computer industry," concludes General V. Williams. "When built in the early 1950s, it was the most sophisticated computer ever designed and the largest computer ever built. I've had IBM people tell me they made a quantum jump in computer technology because of the SAGE program. As a result, this country has benefited in computer technology. Maybe the development would have come along anyway. But I believe, from my conversations with the computer people, that it was speeded up by a number of years. And gave us a world wide lead in computers. With the result, this country has been paid back for its investment in full."





Central New York's Regional Planning and Development Board's Technical Advisory Committee on Crime Control (CRIMETAC) is, as you may be aware, recognized by the State as the official agency for regional planning in crime prevention, law enforcement, and criminal justice in the Central New York Region.

RPDB CRIMETAC has hired Syracuse University Research Corporation (SURC) to produce an inventory identifying all the agencies and organizations involved in, or related to, crime control activities in the five counties of Cayuga, Cortland, Madison, Onondaga, and Oswego, and to identify their resources.

We are contacting you in the thought that your resources — even though not directly part of the "criminal justice system" — should be taken into consideration since they could have applicability in special or emergency situations.

Naturally, your replies to this questionnaire in no way commit you or your agency to anything. The information you provide will be kept confidential and will not be released in any manner to identify you without your express written permission.

It is essential that CRIMETAC have complete basic information on the total resources of the area in order to plan and take action to improve the effectiveness of the region's crime-control activities. The inventory, once completed, will be available to all concerned agencies to assist them. Its success, however, depends upon your cooperation with SURC, which we have asked to deal with you directly in their project.





Planning is now underway for the Eighteenth National Security Forum to be held at the Air War College. Tentatively, this year's forum is set for the second week in May 1971. Seventy-two distinguished civilian leaders (American citizens) will be invited to participate with the students of the college. Last year's forum was an outstanding success according to the commander of the Air University. Comments received from the guests showed that the time they spent contributed substantially to their better understanding of our national security problems and the role of the armed forces in our society.

Major air commanders have been asked to nominate prominent men and women who are interested in problems of our society and our national security. Since the forum's value is dependent upon the calibre of the guests, the nominees should represent the broadest possible cross section, with responsible representatives from all professions such as education, law, industry and religion; and, it is hoped, with greater representation from the news media, labor, minority groups and local, state and federal governments. 1. Annually, the Secretary of Defense appoints approximately 20 women to three-year terms as members of the Defense Advisor Committee on Women in the Services (DACOWITS). The new member will be selected on the basis of their reputations in a business, a profession, or public service and their record of civic leadership. We have been advised that this year the Committee will be losing Medical, Public Information and Professional Education representatives. Therefore, qualified nominees from these fields would be most appropriate and their chances for appointment to the Committee would be increased. A fact sheet on DACOWITS is inclosed (Atch 1).

2. The Air Force has been requested to submit nominations for the 1971 DACOWITS. Since geographic representation is also a selection criterion, only those commands with facilities in specified states will submit nominations to SAFOIC by 2 July 1970. These commands are: AAC, AU, ADC, AFLC, AFSC, ATC, CINCPACAF, HQ COMD USAF, MAC, TAC and SAC. Specific instructions for these commands concerning the submission of nominations are included as Attachment 2.

3. Recently, the Director of Women in the Air Force requested our assistance in orienting DACOWITS members to the Air Force and encouraging contact with individual DACOWITS members. A successful orientation program for the DACOWITS depends largely upon the support of information officers at all levels. Command information officers should establish and maintain close coordination with their command WAF Staff Directors in arranging activities for Committee members.

4. You are strongly encouraged to pay particular attention to the orientation of DACOWITS members by reviewing the current DACOWITS membership roster (Atch 4) and assuring

that the base listed beneath the name of each Committee member offers her a tour and briefing at that base by 31 December. This orientation, whenever possible, should include visits to those base activities where WAF and nurse personnel are assigned. Additionally, DACOWITS members should be invited to base-community functions and command orientation tours frequently throughout the year.

5. For your information and use, biographical sketches of Committee members are inclosed (Atch 5).

1. Annually, the Secretary of Defense appoints approximately 20 women to three-year terms as members of the Defense Advisory Committee on Women in the Services (DACOWITS). The new members will be selected on the basis of their reputations in a business, a profession, or public service and their record of civic leadership. We have been advised that this year the Committee will be losing Medical, Public Information and Professional Education representatives. Therefore, qualified nominees from these fields would be most appropriate and their chances for appointment to the Committee would be increased. A fact sheet on DACOWITS is inclosed (Atch 1).

2. The Air Force has been requested to submit nominations for the 1971 DACOWITS. Since geographic representation is also a selection criterion, only those commands with facilities in specified states will submit nominations to SAFOIC by 2 July 1970. These commands are: AAC, AU, ADC, AFLC, AFSC, ATC, CINCPACAF, HQ COMD USAF, MAC, TAC and SAC. Specific instructions for these commands concerning the submission of nominations are included as Attachment 2.

3. Recently, the Director of Women in the Air Force requested our assistance in orienting DACOWITS members to the Air Force and encouraging contact with individual DACOWITS members. A successful orientation program for the DACOWITS depends largely upon the support of information officers at all levels. Command information officers should establish and maintain close coordination with their command WAF Staff Directors in arranging activities for Committee members.

4. You are strongly encouraged to pay particular attention to the orientation of DACOWITS members by reviewing the current DACOWITS membership roster (Atch 4) and assuring

that the base listed beneath the name of each Committee member offers her a tour and briefing at that base by 31 December. This orientation, whenever possible, should include visits to those base activities where WAF and nurse personnel are assigned. Additionally, DACOWITS members should be invited to base-community functions and command orientation tours frequently throughout the year.

5. For your information and use, biographical sketches of Committee members are inclosed (Atch 5).

The Defense Advisory Committee on Women in the Services (better known by its short title DACOWITS) was established in 1951 by the Secretary of Defense. Limited to a membership of 50, DACOWITS is composed of civilian women who are selected as members on the basis of their outstanding reputations in business, a profession, or public service and their records of civic leadership. Equitable field-of-interest and geographical representation are also selection factors.

Members are appointed to DACOWITS by the Secretary of Defense for three years. They serve as individuals, not as official representatives of any group or organization with which they are affiliated. Semi-annual meetings are held in Washington, D. C.

The purposes of this civilian committee include: (1) to interpret to the public the need for and the role of women in the services and to promote public acceptance of military service as a career field for women, (2) to advise the Department of Defense on policies relating to women in the services, (3) to recommend measures to insure effective utilization of the capabilities of the women in the services, (4) to recommend standards for the training, housing, health, recreation and general welfare of women in the services.

Each DACOWITS member, in her particular field of interest and geographical area, endeavors to increase public acceptance of the concept of military service for women as a facet of good citizenship. To this end, the Committee develops and carries out a continuing and unified education program about women in the services -- Army WAC, Navy WAVES, Air Force WAF, Women Marines, Army Nurses, Navy Nurses, Air Force Nurses, Army Medical Specialists, Air Force Medical Specialists and Women's Specialists Section, Navy Medical Service Corps. They seek to promote understanding of the principal need for women in the armed forces in peacetime -- to maintain a nucleus of trained women to serve as the framework for absorbing thousands of women, utilizing their capabilities effectively and quickly, in case of national mobilization.

In those states where more than one command has installations, cross command coordination will be effected to eliminate the possibility of duplicate nominations. In those states (Iowa, Kentucky and Vermont) which do not have extensive Air Force facilities, nominating responsibility is delegated as follows: Iowa and Vermont - SAC, Kentucky - MAC.
2. The following information must be provided on each nominee: maiden name, place and date of birth, present home and business address, present employer, and husband's name, date and place of birth. Other details such as organizational affiliations, awards and honors, prior military service and as much additional information on each nominee as can be provided will assist greatly in making final selections. Three copies of all nominations will be submitted in the format shown in Atch 3. Since only a small percentage of those nominated can be appointed, discretion should be used in obtaining biographical information in order not to alert prospective nominees that they are under consideration for Committee membership. Assistance in selecting nominees will be obtained from command WAF Staff Directors.
3. Nominations will be sent to HQ USAF (SAFOIC) to arrive not later than 2 July 1970.


Dear General Williams:
