A KARL PFLOCK ALERT

Recent events have dictated that I alert the UFO community and the Roswell researchers in particular to what appears to be a three front attack on the Roswell case by the Air Force, the established debunkers, and Karl Pflock. According to Stanton Friedman the recent Air Force propaganda report on Roswell was written by USAF Colonel Richard Weaver who works for the Air Force Office of Special Investigations. Stanton says Weaver is now at the Region 2 OSI District Office at Langley AFB near Hampton Virginia. Karl Pflock is a past employee of the CIA and the DOD. The established debunkers are well known in UFO circles and their activities are nothing new.

What is new is the resurfacing of Karl Pflock in the UFO community in the last couple of years with his wife Mary Martinek acting as Representative Schiff's Legislative Director and who also appears to be a filter for the UFO material reaching Representative Schiff. My belief that confidential information being sent to Representative Schiff was being leaked out of Schiff's office to others, particularly to Karl Pflock by his wife Mary Martinek, was confirmed recently. I received a phone call from Mary Martinek about 2:30pm on October 11, 1994. This phone call was I believe an attempt to get me to withdraw a letter I had written to Representative Schiff disclosing a problem I had with Mary. In this phone call Mary admitted to me that she had disclosed the letter, its contents, and my name to Fred Whiting. I had good reason to believe that Karl Pflock had also been briefed and Mary would not answer my question asking if she had briefed Karl. It seems that Mary had held on to this letter for as long as a week and had not yet disclosed it to Representative Schiff. She said she would give it to Representative Schiff in the future.

While the Roswell researchers squabble amongst themselves over who is the most credible and the best researcher, Karl Pflock is quietly gaining legitimacy as a respected Roswell researcher by developing a friendship with Fred Whiting and having his work endorsed by the Fund For UFO Research. Having developed these credentials, it appears that Karl Pflock is about to provide Colonel Weaver, the Air Force and the established debunkers with phoney research that will give teeth to the Project Mogul cover story. According to a major Roswell researcher Karl is attempting to persuade witnesses to back off from their testimony. Karl tells some investigators that the alien theory may be true and to other more skeptical investigators he says he doesn't believe the alien theory for the Roswell crash. What this looks like to me is a debunker in sheep's clothing who is working for a advantage while the sheep bicker.

I believe soon the war for the peoples right to know will explode in the press when the mainstream debunkers feed their media outlets like the powerful AP Washington bureau more project Mogul propaganda. Right now most of the media aren't buying the Air Forces Mogul Balloon cover story but if the propagandists can come up with a fabricated explanation with teeth then watch out. I hope the UFO community can put the squabbling aside for a while in order to better determine what the debunkers and propagandists are up too. It would be a shame to see the Roswell case falsely discredited by the debunkers. Now would be a good time to bring up other crash retrieval cases to the media just in case the debunkers are able to so confuse the Roswell case that it becomes useless.
