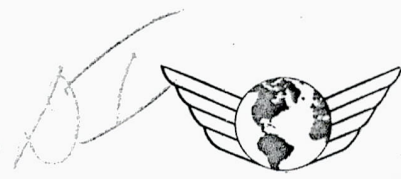

- (1) Description of the object:
 - (a) Shape - Round
 - (b) Size compared to a known object: Nickel held in the hand at arms' length
 - (c) Color - White
 - (d) Number - One (1)
 - (e) Formation, if more than one - N/A
 - (f) Any discernible features or details - Object was intensely bright, similar to an electric light blub.
 - (g) Tail, trail, or exhaust, including size of same compared to size of objects - Mr. N. E. Clanton (further identified in 6a below) stated he observed several exhausts around outer edge of object. These exhausts seemed to be making the object move counter-clockwise.
 - (h) Other pertinent or unusual features - None
 - (i) Sound - None
- (2) Description of course of object:
 - (a) Mr. [REDACTED] and Mr. [REDACTED] first observed object by looking at the sky. Mr. [REDACTED] and Mr. [REDACTED] sighted object after Mr. [REDACTED] called their attention to it. Mr. [REDACTED] was located approximately 300 yards from the other men and did not have any communication with them.
 - (b) Angle of elevation approximately 75° and azimuth approximately 340° when object was first sighted.
 - (c) Angle of elevation approximately 75° and azimuth approximately 110° when object disappeared.
 - (d) Object first appeared to be a falling star but as it got closer to the earth it got larger until it was approximately the size of a nickel. It remained the size of a nickel for a few seconds then it did several distinct movements up and down, again it stopped about the size of a nickel. Next it resumed movement toward the sky, then stopped and started in a south east direction once again. Halting and then moved towards the east until it disappeared.
 - (e) Object dissappeared behind clouds.
 - (f) Object was in sight approximately ten (10) minutes.

 - (a) Ground visual
 - (b) No optical aids were used
 - (c) N/A
