Sources viewed object from airport. The objects appeared to be two illuminated cylinders high in the sky. The elevation was about 25° above the western horizon. A "fireball" was seen to drop from one object. The two objects drifted together then apart. Ten minutes after the original sighting, they started to climb at a rapid speed.
