Subject: Flying Saucers, Report of;

1. The following information is reported to your office for proper disposition of the information that was given confidentially to me by Lieut. Charles Kinzel, Chief of the Washington State College Police Force, Pullman, Washington, on the morning of 24 July 1950, when he and I were discussing some of the traffic problems as they pertain to the Campus here at Washington State College.

- 2. Chief winzel is a member of the Washington State Patrol, on detached duty here at Washington State College. Chief Kinzels interest in flying saucers is as high as many of the other persons in this area, and he has always been on the watch for one of the flying saucers or to talk to a person who has seen one. Chief Kinzels statement to me pertaining to flying saucers was substantially this. I did not press him for additional information at the time as I did not want to arouse his interest and felt that he had told me everything that had been told him.
- 3. Kinzel's information to me. ---- " Here is some conflidential infomation that was told to me by a member of the Washington State Patrol---Patrolman who is stationed in the Horseheaven mills district here in the State of Washington was called to a location in the Horsehaven hills about two weeks ago by an excited citizen who had found a strange metal object, that was saucer shaped. Then saw the object, he could see that there was some written material on it and followed the directions of that written material. It was not long until an "rmy officer from the Panford "tomic Project, Aichland, Washington, arrived at the scene and quickly picked up the object. A discussion between the military officer and the State patrolman --- and it was not stated by the original person who had found the object was still present --- followed pertaining to flying saucers. That conversation was substantially this --- Flying saucers are of thr e sizes, some small like the one found in the Horseheaven Hills which was about 6 inches thick and 20 inches in diameter, others larger and the largest ones up to 250 feet in diameter. So e are guided missels, others are not, some are capable of carrying payloads, others are not, some are niloted by human beings. Ley are powered by atomic energy and can travel as fast as 3600 miles cer Words. That they are launched at the Hanford "tomic project. That the article the labreared in the Readers Digest of July 1950 contains additional information that Protest could learn if he had not already read the article.

4. I have read the Readers list anticle and am wondering about the final paragraph at the end of the article. "Thy one democing or remealing description or whereabouts of this missel is subject to prosecution by the inited States Government."

5. This memo to the DIO officer is sent by me with the interest of the security of secret data pertaining to the security of the United States. The question in my mind id; Did the military officer who talked to Patrolman Pruitt violate the security measures of his office?
