008 BEARING 305 DEGREES PARALLEL PIPELINE ENROUTE FROM DHAHRAN
TO TRIPOLI. FLY OBJECT APPROACHED FROM DIRECTION OF 305
DEGREES GIVING OFF INTENSE LIGHT IN EARLY DAWN AT "TERRIFIC"
SPEED BUT PEELED OFF LONG BEFORE REACHING PROXIMITY OF C-54
AT RIGHT ANGLES IN SHALLOW BANKING CURVE. 2 OBJECTS THEN
VIBRATED WITH FLAMES STREAMING TO THEIR REAR. WITHIN 10 TO
