10. BRIEF SUMMARY OF SIGHTING One (1) round object, the size of a matchhead held at arms length, estimated to be be the size of a large type bomber aircraft. It was estimated that the object was at 40,000'. Object was silver in color (described as being like aircraft in color.) Observers' attention attracted by jet passing overhead, then they saw object. It moved slowly at first and then appeared to gain speed. Speed estimated to be from that of jet a/c to 1,000 MPH. (NO CASE IN FILE)				11. COMMENTS The two SOURCES were telephonically interviewed by this hq. Both were of dubious reliability in the opinion of this hq. Negative results were obtained when this hq tried to contact pilot of jet a/c seen just before object was seen. Both SOURCES admitted the possibility of the object having been a high flying a/c when queried. Lack of contrail and gain in speed convinced the SOURCES (at time of sighting) that the object was not an aircraft. Resolved as a POSSIBLE AIRCRAFT
