Case too old to investigate and quality of data too poor to offer any valid suggestions as to the cause of the sightings.
4. NUMBER OF OBJECTS Three	11. BRIEF SUMMARY AND ANALYSIS Observation at about 2130 on a summer night in 1964 reported to the Air Force in a letter in 1965. Witness was looking WEST talking to others looking EAST. Looked up and saw an object that appeared to move silently Westward. Looked like a blue light but was not glowing and had no tail. Speed was too fast for an a/c and too slow for meteor. Disappeared before anyone could turn around and see it. About one minute later a light that looked like the funnel of a tornado appeared in the Southern sky. This light lasted a few seconds. Nothing happened after that.

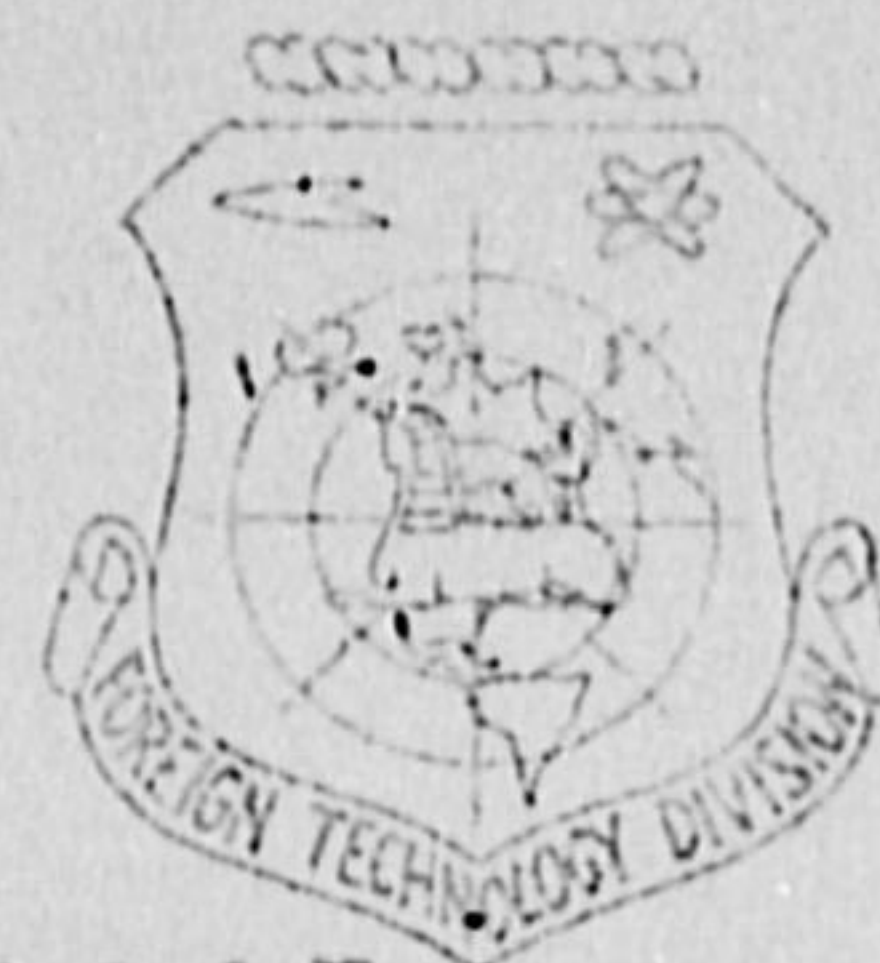

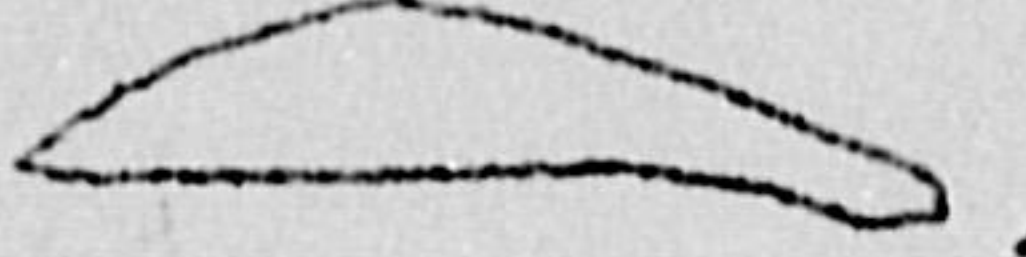

and just happened to look up when

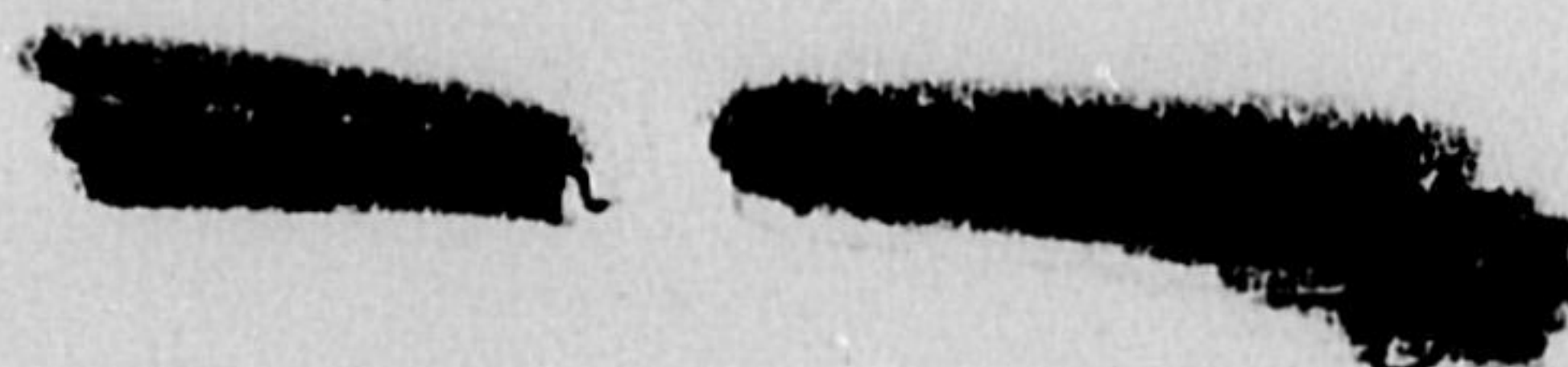
