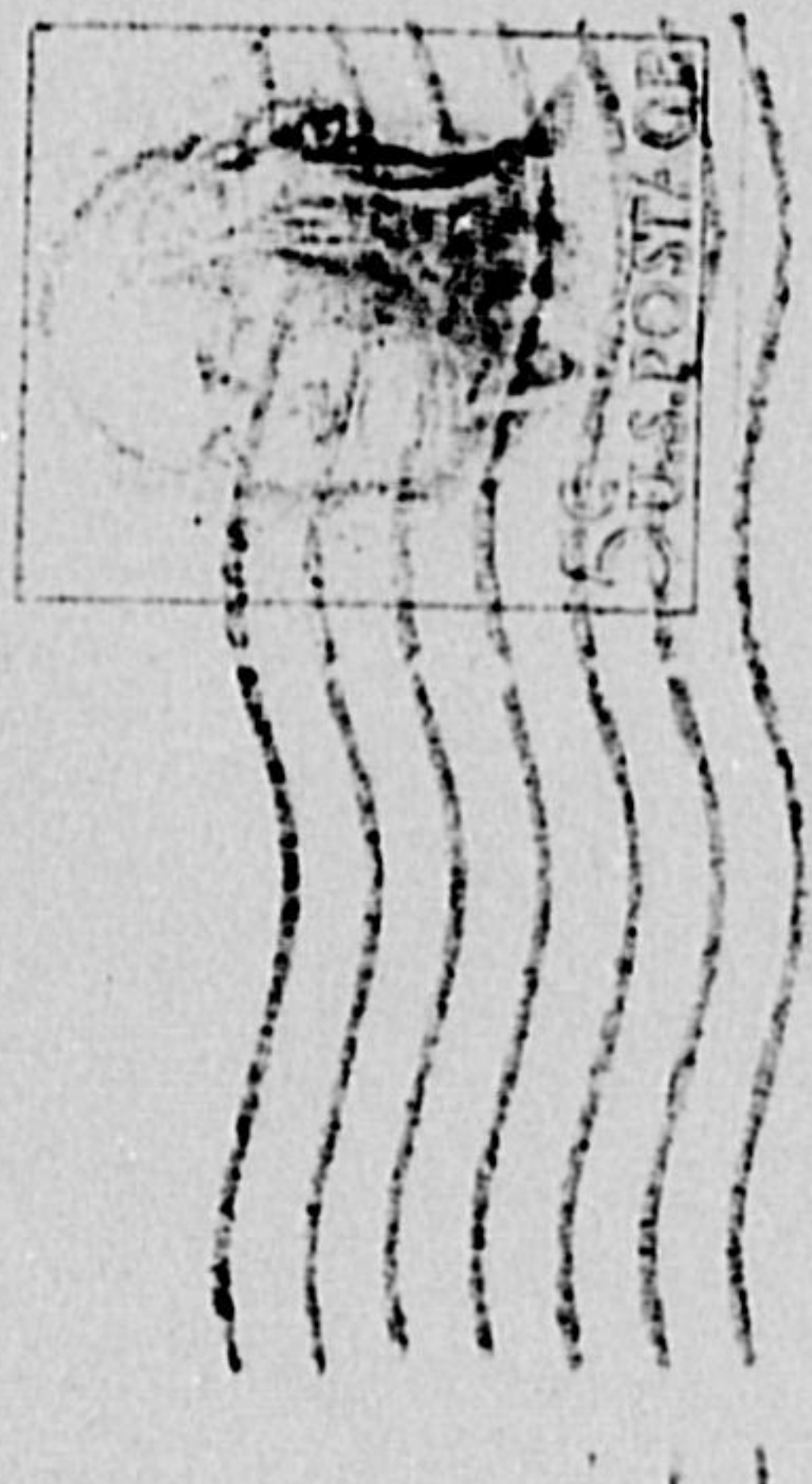
Until the night of July 1 this year I have been very skeptical of reports of UFO sightings. On that night at approximately 11:45 there appeared out of the east a large luminous object so bright it was impossible for me make out any special shape. It seemed to hover, in a wobbly sort of way like a huge lantern, and then changed course and disappeared into the north. After it turned to the north it lost some of its brightness but remained a shapeless blob. There were no blinking, alternating lights such as we see on conventional airplanes, nor were there any bizarre antics which we so often read about in reports.

The enclosed clipping has led me to send this report. It was sent to me by my daughter-in-law who was visiting me at the time and watched the phenomenon with me. The clipping is probably from a Kansas City, Mo. paper or one of the Topeka, Kas. papers. If there is an explanation for an object of this sort it would be most interesting to hear it.

There were other reports of this kind in this general area at about the same time. There is surely some logical explanation for such strange looking objects and we'd like very much to have one.

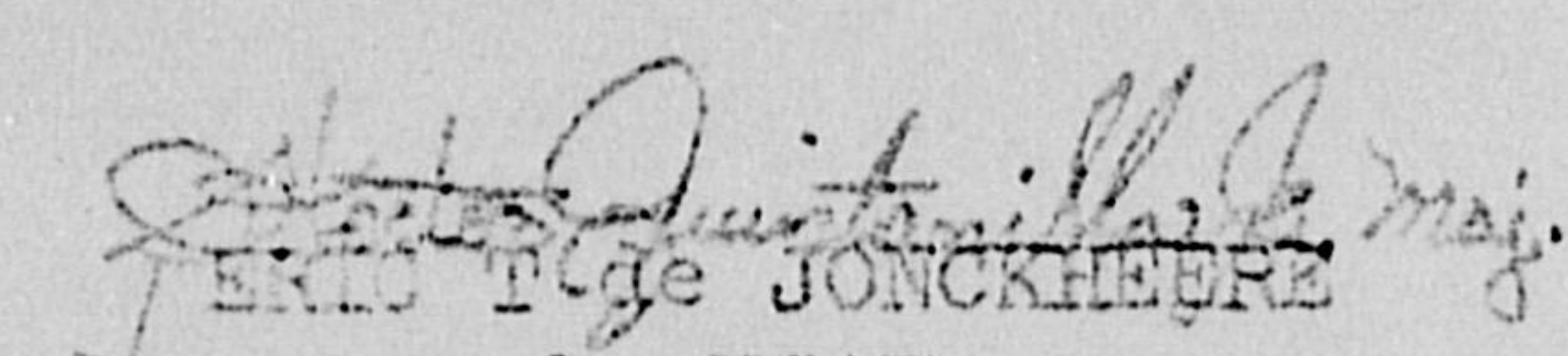

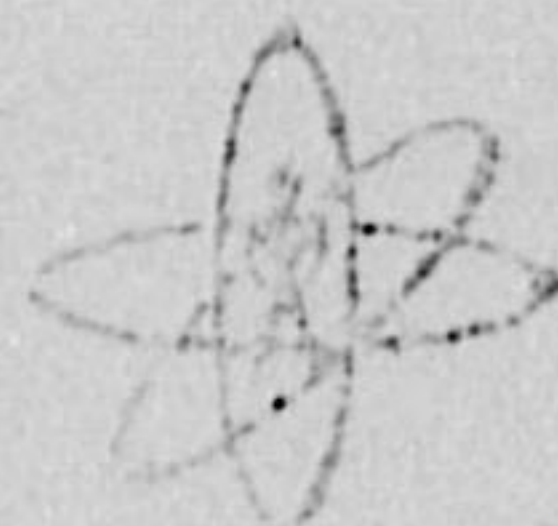
