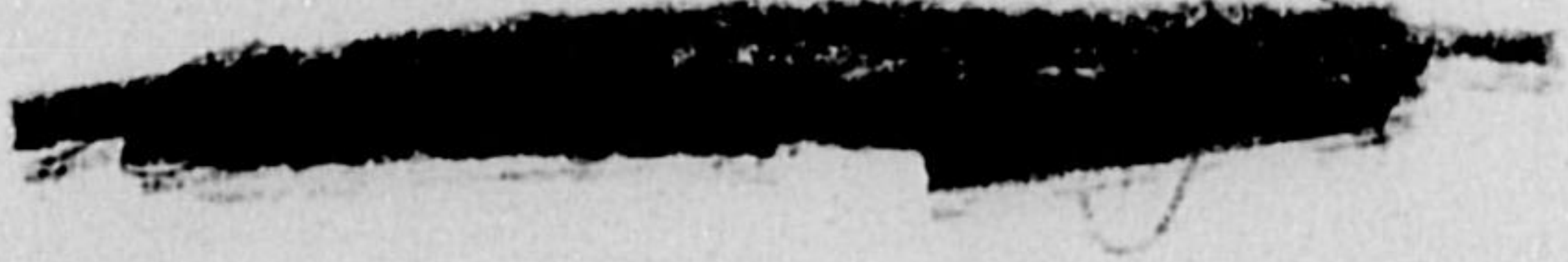

Dear Sirs,

I am writing this letter to report an Unidentified Flying Object which was observed in New Iberia, La, on July 11. I am sorry about the lateness of the report, but was on vacation at the time.

There was no moon and the sky wasn't too cloudy. There was no wind. My Grandfather called me outside to show me something. He said he had been watching an object or star for an hour when it shot accross the sky. He said it had attracted his attention because it seemed to be moving and was three colors (red, white, and green). He showed me where it was now. At first glance it looked like a star. But then I could see it had red, white, and green lights. Also it was doing different kinds of manuevers. I got my four cousins out to see it. Their age's are 12, 15, 17, 20 and I am 15. We got the binoculars and a telescope out. We never could get anything out of the telescope as it didn't have a stand and we couldn't find the object in it. We all took turns with the binoculars and clearly saw the object. To me it appeared as a glowing jet with red and green lights. It did zig-zags going from up to down, went back and forth, and went in circles. One time through the binoculars it looked like it was going to crash as it was headed down and was spinning. Sometimes the Red light would flare up much brighter than normal. My Grandfather saw the object from 10:30 p.m. to 11:30 p.m. when he called us, and we watched it from 11:30 p.m. to 1:30 a.m. Several times we called the Naval base. Once he said he didn't know what it was and that it wasn't a plane. Another time I called he said he called the Lafayette Air Station and they reported it was a "star". The object was to the west. On July 13 while in Ft. Worth, I heard on the radio that reports were coming in from different areas of Ft. Worth of a UFO and that the discriptions were the same.

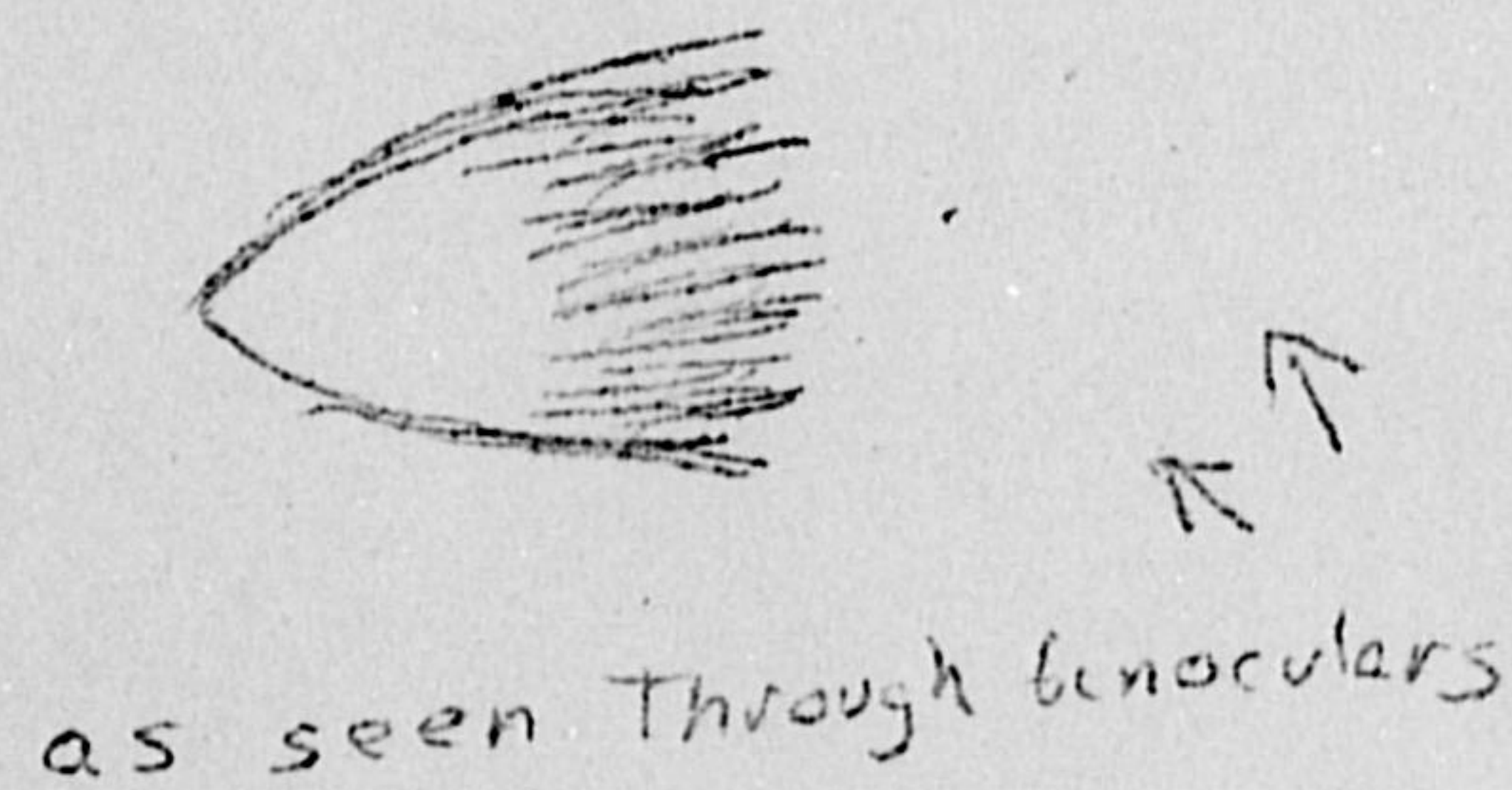
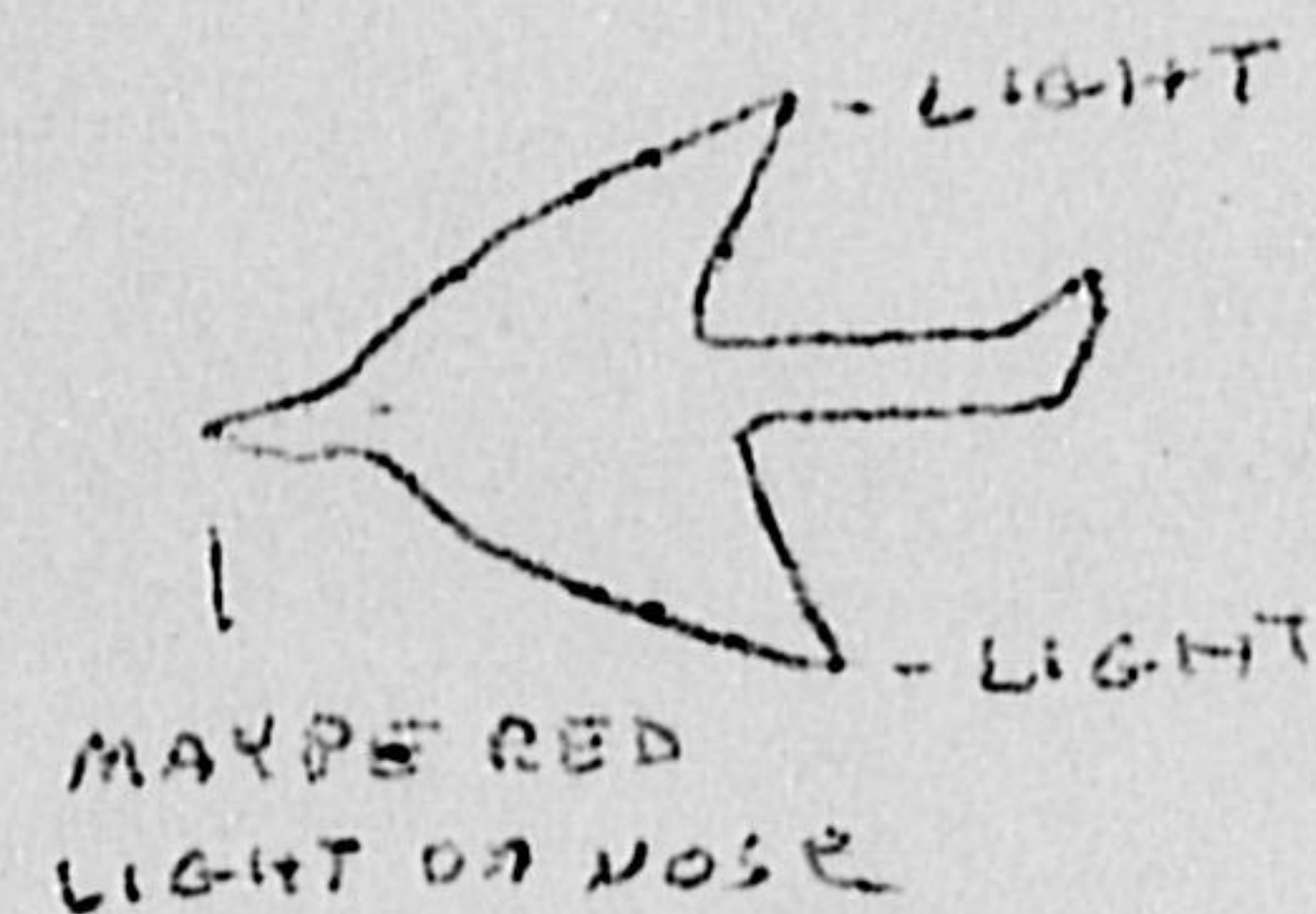

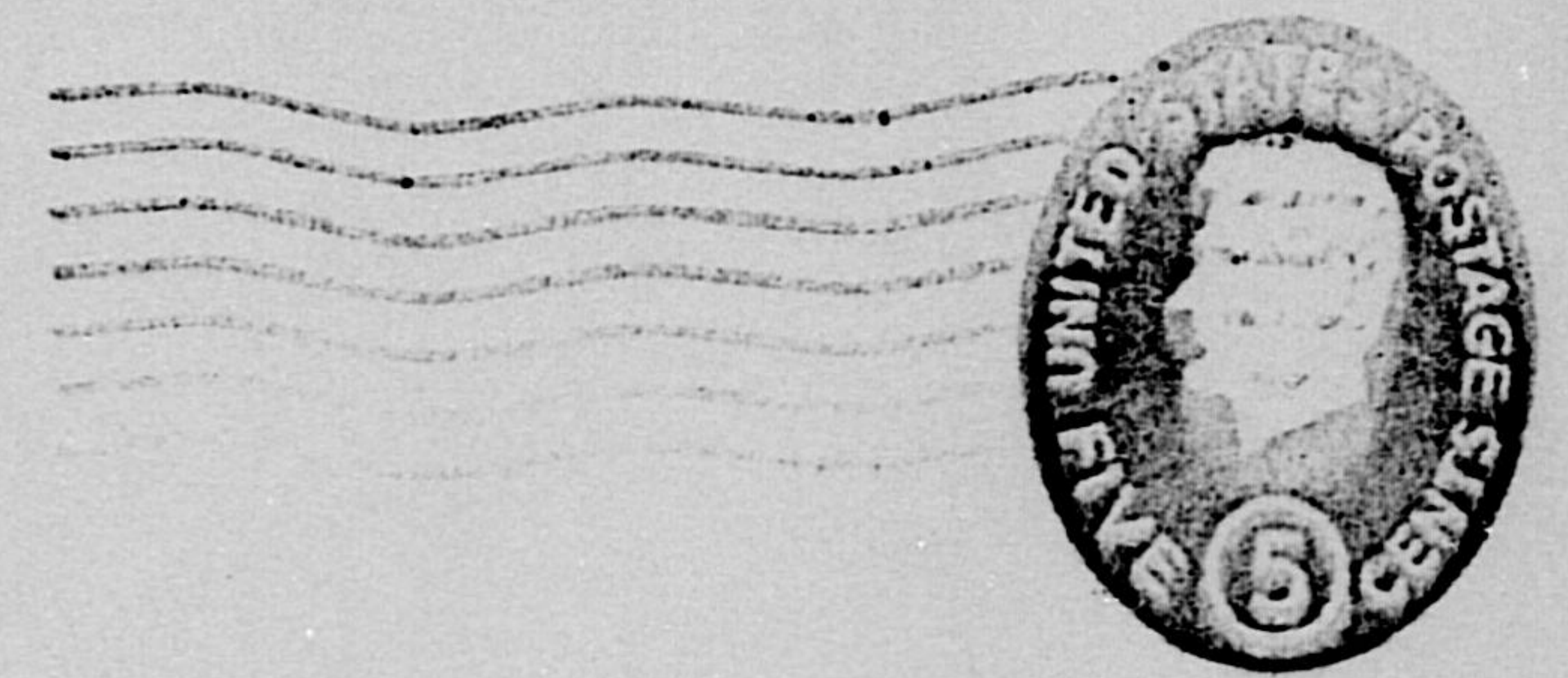

The Air Force entered into a research and development contract with Avro Aircraft Ltd., of Canada, to study possible military use of what is known as "the ground effect." The test vehicle did have a saucer-like shape due to use of the "ducted fan principle" as a means of propulsion. Over seven million dollars was spent in this area of research and when they completed their work in December 1961, they determined there was no possible military application. Above an altitude of four feet the vehicle was dangerously unstable. Final tests had to be conducted with the machine anchored to the ground with ropes.

Material on unidentified aerial phenomena is inclosed for your information.

Also I have read in a book (published 1956) that the U.S. is developing a saucer in Canada. I would also appreciate it if you could give me information you have available on that.

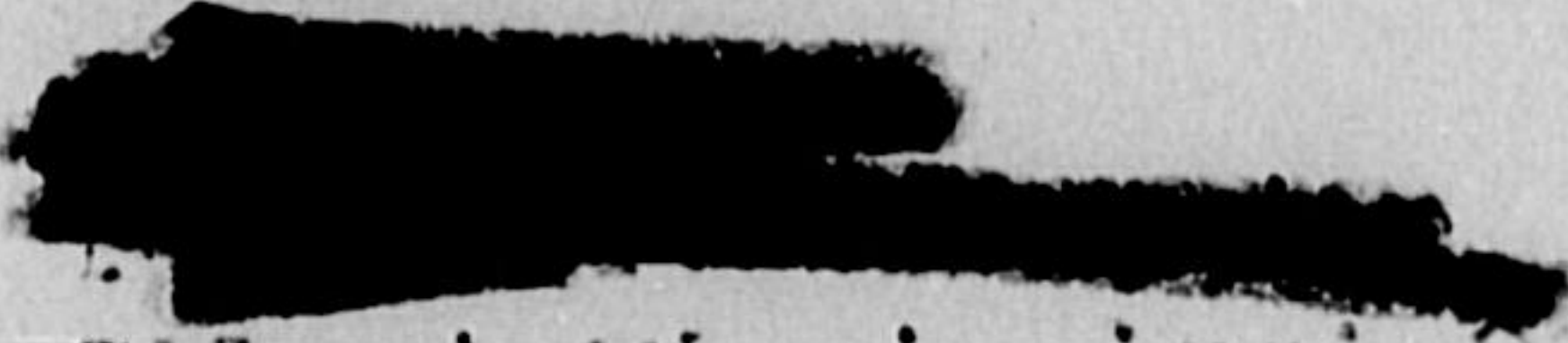

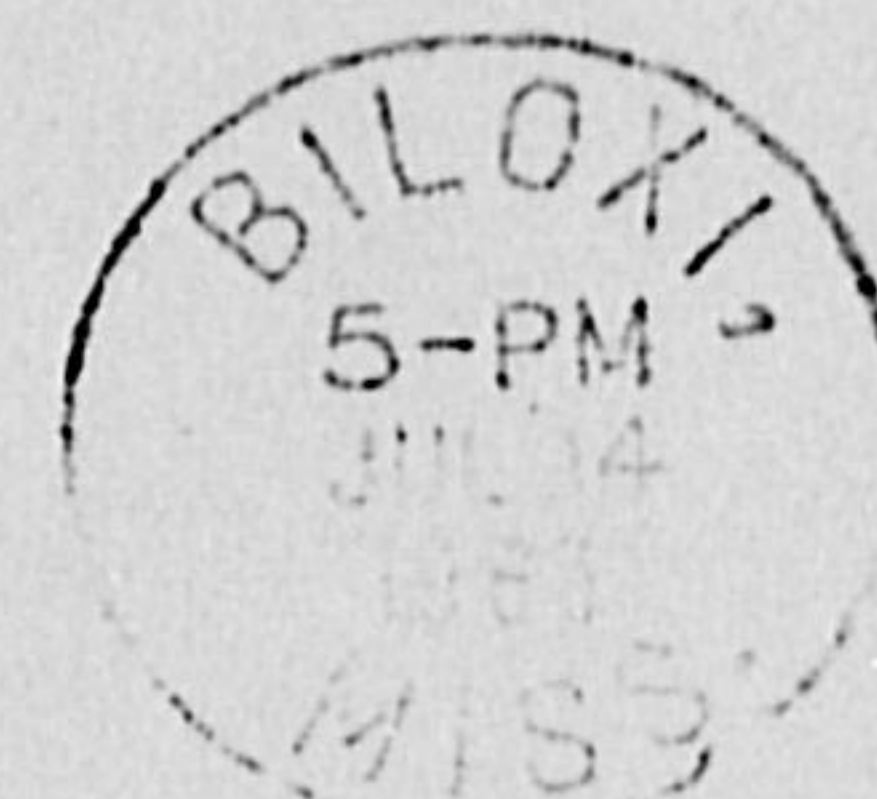
