Dear Sir,

Please excuse my tardiness and hesitancy in sending you this letter. However, in view of the fact that of late many UFO reports have appeared in the newspapers, I believe my prior assumption and fear of being called a crackpot are baseless.

On the morning of July 17, 1965, between the times 0347-0351 Central Daylight Time (CDT) I did observe and unidentified flying object.

I had just gone on a ten (10) minute break from my job as a dumper on the pea platform at the Green Giant Company, Glencoe, Minnesota. I started for the mens room which is only a short walk from where I perform my work. About mid-way between the platform and the mens room I came upon one [REDACTED] and one [REDACTED] looking up into the night sky.

As I drew nearer to them [REDACTED] said to me, "Hey [REDACTED] What is this thing?" I stopped near them and looked up to see a cream-colored object with two faint, redish-orange spots traveling slowly in a south by south-easterly direction. I told them I did not know what it was, other than that while I had been in Japan I'd seen F-104 jets fly with their landing lights on, and this looked quite similar. Although, this still looked a little odd because of its slow speed and dual redish-orange spots.

We stood there watching for perhaps 20 seconds. Then passing it off in my mind as nothing to become excited about I continued on to the mens room. My hands were quite dirty so I therefore washed them and returned out side at approximately 0349 CDT. I glanced up again to see the object coming from the east, over the Green Giant plant.

From where I stood I looked at the object, glanced at the plant building (for bearings) and noted the time on my wrist watch as 0349 CDT. I watch for perhaps 30 seconds and then walked about five (5) feet closer to the corn processing building. I watched for a few seconds and drew another fellows attention to the object. (he had been watching me and must have thought I flipped my lid.)

I watched from my view point till the object reached the first of three power lines running between the corn building and the transformers. I again noted the time as 0351 CDT. I kept watching and counted off one-thousand-one, one-thousand-two, and finally one-thousand-three as the object moved between the second and third power lines of the afore mentioned set of three.

I watched a bit longer as the object moved off in a westerly direction. I then turned and headed back toward the platform.

As the object was moving over head it progressively changed from a cream color to a whiter, silverier color as more of the bottom came into view. When the object was so placed so that I could see directly straight up at it, it suddenly became very bright in silver and bluish color and hue. It was almost as if magnesium was burning or a welders torch was in operation.

When I reached the platform I again saw [redacted] and another fellow watching intently in a westerly direction. I start walking toward him, and as I drew near he said, "Did you see it light up?" I told him I had and turned to tell some of the other fellows what I had seen.

That's all there was as I saw it. I might mention however that the height was approximately eight (8) to ten (10) thousand feet.
