Object was in an oblique pacing movement with three aircraft flying in formation in a N.E. direction. Object was silvery and red in color being exceptionally bright. Since Echo I was in the area 20 minutes earlier and witness said object was observed at about 0140Z it is quite possible the witness was observing Echo I.

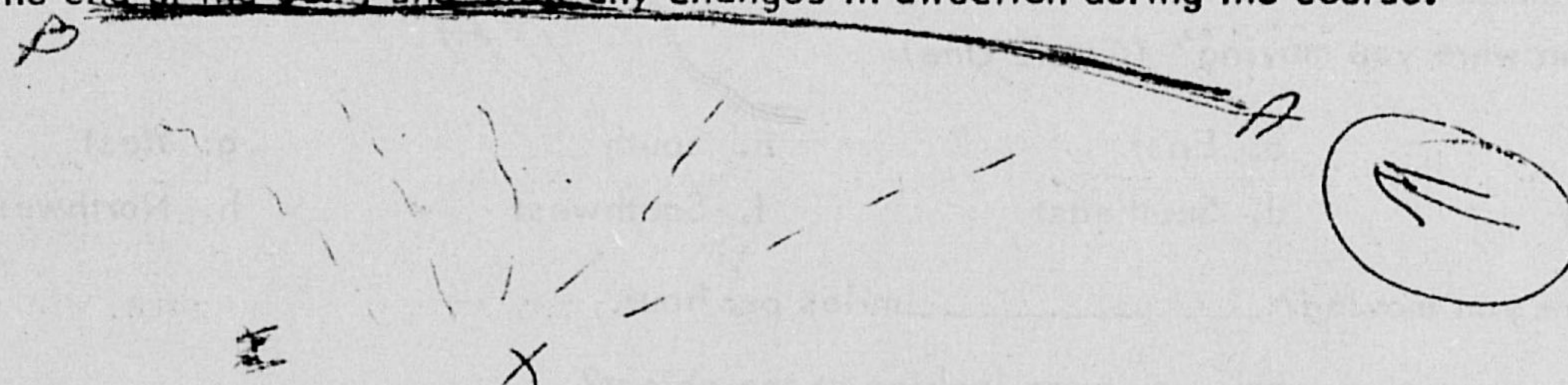
