I was told by the debriefing officer immediately after the incident that I was not submitting a UFO report but rather an unusual Incident Report. I was in full agreement with this and was not aware that I had submitted a UFO report until I received your correspondence. Someone apparently changed this without my knowledge.

I agree fully with your conclusion that aircraft could have been responsible for this observation. This was my stated opinion to the debriefing officer. I stated that I believed this observation to be two small aircraft in formation.

I hope this will clear up any questions you may have regarding this observation.
