

SUBJECT: UFO Report

TO: AFSC (FTD)

- 1. The following information was reported to Dispatcher John L. Fox, Operations Branch, at 2200 hours on 21 Nov 1966:
 - a. Description of the object(s) observed:
 - (1) Shape first it was round then heart shaped.
 - (2) Size approximately 15 feet in diameter.
 - (3) Color bright red (sparkling).
- (4) Number started with one then there were a few (exact number unknown).
 - (5) Formation not applicable.
- (6) Discernible features bright then appeared to turn, becoming weak and then back to bright.
 - (7) Tail, trail, or exhaust none.
 - (8) Sound none.
 - (9) Unusual features none.
 - b. Description of course of object:
- (1) Observers were preparing to go to bed, looked out the window and saw it.
 - (2) Angle of elevation and azimuth approximately 45 degree angle.
- (3) Description of flight path appeared to be moving west very slowly.
- (4) How object disappeared object did not disappear during observation.
- (5) Length of time in view 15 to 20 minutes prior to call and 5 to 10 minutes during call.

- c. Manner of observation:
 - Ground-visual.
 - (2) No optical aids used.
- d. Time and date of sighting:
 - 0700Z, 22 Nov 1966.
 - Nighttime.
- e. Location of observers looking out window of house at 2649 3d Avenue. Sacramento, California.
- f. Observers Mr. Change, 81 years of age and retired; and bousewife, 80 years of age.
 - g. Weather and wind conditions at time of sighting:
 - Observers account unknown.
- McClellan AFB, California 44°, Dew Point 43, winds 180° at 5 knots.
 - (3) Ceiling unlimited.
 - Visibility 15 miles.
 - (5) Cloud cover none.
- h. McClellan AFB Weather Station reported that there were no meteorological weather phenomenon in the area at the time that would cause a mirage or unusual sighting.
 - i. Interception none.
- j. Base Operations, McClellan AFB, reported that there was one DC-6 departing at 2400 hours, one C-121 departing at 2324 hours, and one C-121 arriving at 0007 hours.
- k. From all information obtained the two listed observers are the only ones known that saw the object. The control tower failed to see it and the Civil Law Enforcement agencies had no reports. City Police indicated the observer (Mr Hack) is known to them and has called them on various items.
