MARRATIVE: On Tuesday evening, 22 November 1966, Mr. And his assistant museum director were driving from Vaughn, NMex to Roswell, MMex on Highway 285. Leaving Vaughn at about 1930 MST they noticed what they thought was "an awfully bright" star after driving about 20 miles. The "star" was about 35 degrees above the SE horizon and was a bright white light. They drove on trying to figure out what star it was.

The light then moved west across the highway and dropped to 20 degrees above the horizon, so they stopped the car to take a closer look. No sound was made by it and Mr. described it then as a "pulsating light that would dim out followed by a blinking red light". After the red light the white light would return and so on.

They watched the "UFO" all the way to Roswell arriving about 2100 hours MST. During the course of this time, it moved in the following pattern: after west across the highway it again moved east, then south toward Roswell, then west, then east where they could no longer see it. because of trees, etc. It was east of Roswell when they arrived in Roswell.

The "UFO" moved at different speeds, but was not erratic. It made sharp, quick turns when changing directions as opposed to gradual turns. It was stationary at some points and seemed throughout the evening to change altitudes. Being so far away Mr. Smith and his assistant guessed that it was always south of Roswell.
