Dear Sir:

Regarding my telephoned report to your station 924-5511 ext. 741-2 made last night near midnight of a sighting of a possible UFO.

After further discussion with my co-observer (wife) and checking carefully today with a sweep second hand clock and retracing the "flight" path we real I inadvertently added her time of observation to mine to report a total time of observation of est. 7 minutes.

The more likely total time of actual in sight observation by me was 10 to 15 seconds. It seemed much longer without a time piece.

I had left my wife and son (13) to run 100 feet to the house to get my 70x50 binoculars and run the 100 feet back out. I did not turn on the light because of probable

established for 15 minutes. I did not see the clock clearly until coming back into the house after terminate of observation. In the dark as I picked up my binoculars I believe I read 1155 P.M. From this and later clock check I deduce 4 to 5 minute elapsed time with 10 to 15 seconds actual on target sighting. Needless to repeat but I arrived too late with my binoculars.

Tonight I am loaded with telescopic lens on a Konica single lens reflex with Tri-X film although I realize the very difficult task of photographing anything in the sky at night.

For further consideration I wish to state that I have seen satellites at various times and have observed carefully their relative speeds considering their distance or range away. At first glance, the observed "UFO" last night appeared to me as a satellite. Upon observation even a few seconds or less I realized this could not be such an object because of the tight, abrupt 90° left turn. Further observation led me to believe

was much lower to earth than a satellite and more nearly estimated 5000 feet altitude. (we are at 200' above sea level) If it was a jet fighter then it would appear as the light bluish-white light from the after end of the tail pipe, however, I do not recall ever (1945-1967) visually observing this condition except on straight-away flight of a jet fighter. From this I have to rule out a jet fighter as the configuration of the flight path, especially the first observed horizontal fly by, would not likely demonstrate such a stern view illumination or light. Secondly, all jet fighters I have observed (many when close enough to visually observe tail flame or afterburner were accompanied by substantial sound and often sonic boom. We report NO noise or sound in this sighting.

Further, 90° left tight turns at the velocity of satellites is most unlikely and the tightness or abrupt change in direction precludes all known (to me) jet fighters. It the object is

a jet and close enough to earth to visual.

The light observed was of uniform intensity, not pulsating, not color changing. Comparing it to a known heavenly body I would suggest Polaris the pole star, as observed from our latitude $44^{\circ}38' N$. The magnitude of Polaris and the "UFO" light being very similar and the color being similar. There was no phenomena of the usual star "twinkle" apparent. The light was steady except as it receded eastward and finally on its reverse course back northerly and easterly approx $20^{\circ} E$. mag. Of interest is the note that my wife says the light had an elliptical shape at times. This I cannot verify as it appeared to me much as Polaris does, essentially round.

If the UFO was near the reported 5000 est. alt. then its speed was fantastic, perhaps 800 mph. allowing about 5-6 seconds for the initial horizontal pass of 4 miles estimated.

If the apparent altitude was on the order of most satellites then the apparent speed was much too fast

for any of the ~~4~~ satellites I have observed. This plus the erratic course sort of rules out satellites with me.

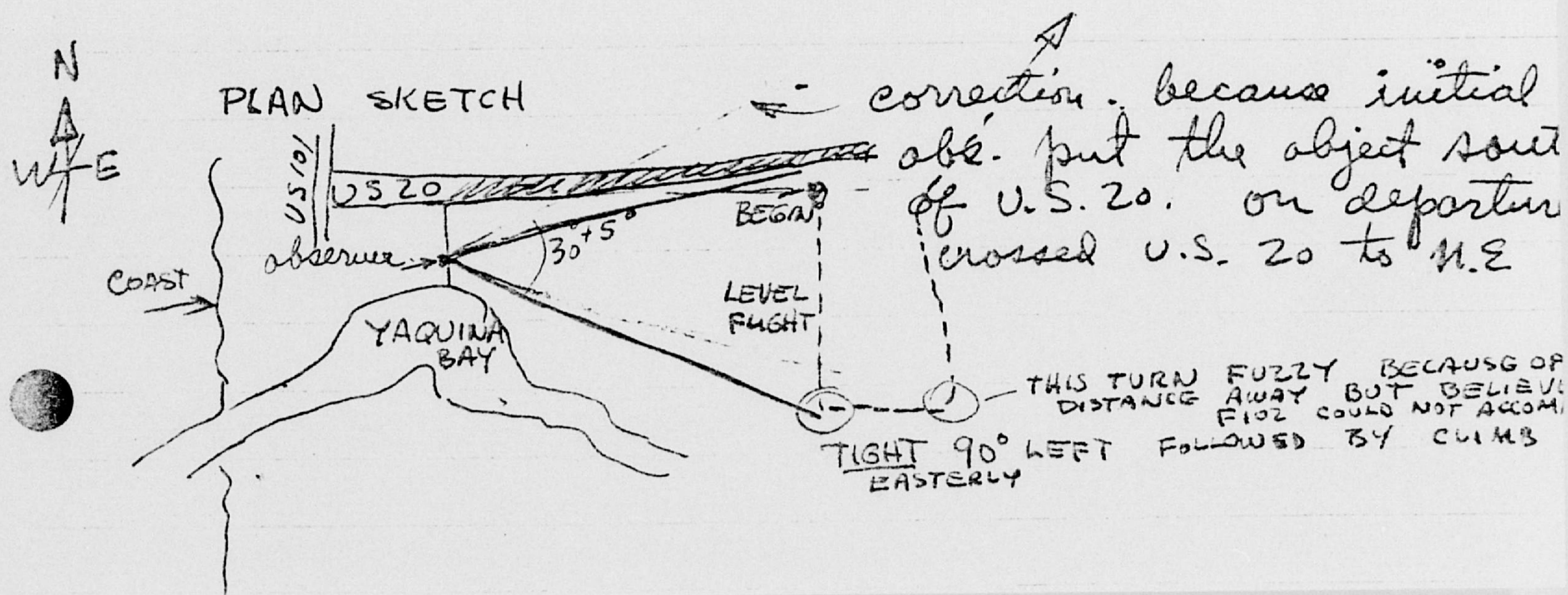
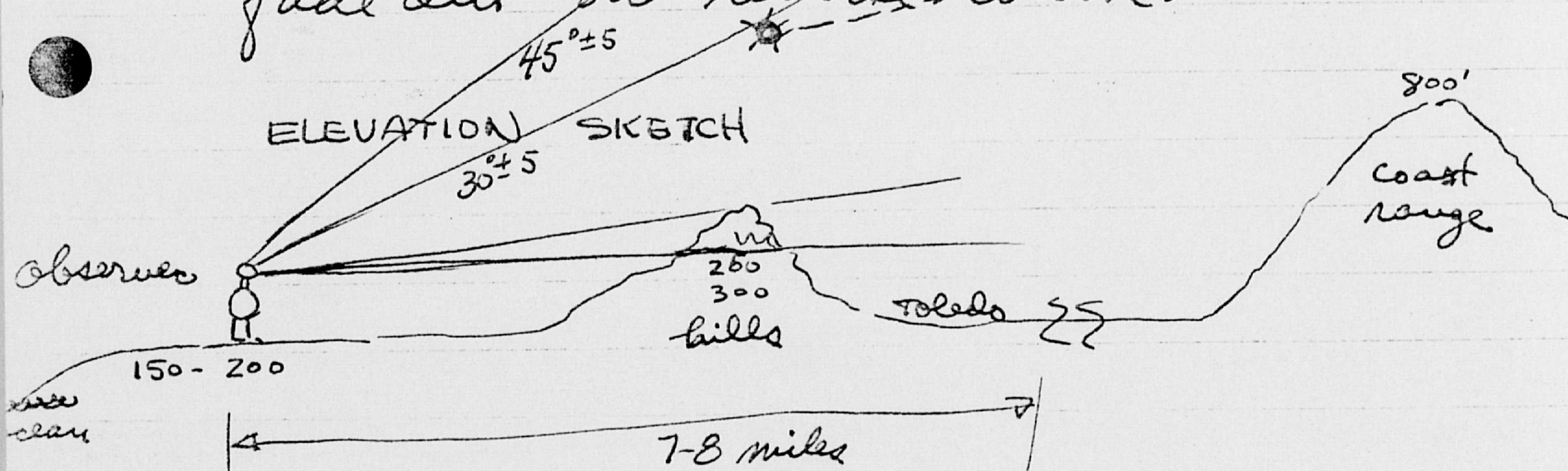
Significant horizontal high speed level "flight" for an estimated distance of 4 to 5 miles north to south, then a 90° abrupt left turn, an easterly climbing "flight" for an estimated 2 to 3 miles, followed by another 90° left turn to a north heading paralleling the initial course and then fading out north easterly seems unusual for a satellite; or a jet fighter, no noise; or a weather balloon, no local ground wind (I do not know the winds aloft in the vicinity of Lincoln County as of last night but have never known them to reverse in less than 5 minutes).

Several things on my phoned report to you may not tie down them.

1. I have no positive way to estimate difference in altitude between let's say an aircraft light of a certain intensity and a reflection light of a satellite at the apparent same intensity but of much greater altitude and distance so my estimated alt. of 5000 may be way off which would throw out my estimation

of ground covered (4 to 5 miles one way)
 For comparison though I could say
 it, the UFO, covered an arc of sky
 in level flight north to south of 30°
 approx.

The angle of light (UFO) above the
 horizon was maximum 45° approx. It
 appeared even as low as 30° on the
 level course, swooping or climbing up
 on the east leg to approx. 45° and
 staying essentially at this angle until
 fade out on reverse course.



my sketch in plan view does not indicate the erratic movements my wife observed as I left to get the binoculars. Her description of the total "flight" differs somewhat from mine but we find solid agreement on

1. no noise or sound. town was asleep
2. steady light observed.
3. color of light similar to Polaris.
4. Extreme high speed.
5. very sharp, tight, abrupt turn of 90° .

Following the fade out of the object recd I observed for approx 5 minutes with binoculars 7x50 but did not see anything more. I returned to house checked the time, phoned the Oregon State Police at Wen (they indicated no sig. interest other than logg it for ref. in case other calls come in) Then I phoned you folks long distance, my mickel, had a little difficulty getting you because I did not know current procedure.

Please advise if there is any significant urgency that I phone such reports or would you be just as happy if I mail them. I want to be helpful if possible
