Thank you for your letter of July 20 about the Kodak Instamatic 100 Camera.

Since the Instamatic 100 Camera has been superseded by the Kodak Instamatic 104 Camera, we are happy to enclose descriptive literature for it.

It has a fixed-focus, f/11, lens, with a focal length of 43mm. The shutter speed is 1/40 of a second for flash, and 1/90 of a second without flash.

It uses 126 film in the cartridge, which we supply for black-and-white prints, color prints, and color transparencies.

We hope this information suits your needs, Mr. Mueller. Whenever we can be of photographic assistance, please let us know.

2. Our letter of June 1, 1967 requested the original negative. Photo analysis personnel are unable to perform a comprehensive analysis with the information you provided. The negatives are needed to determine exact borders, grain structure, etc. Also, there is a discrepancy as to when the photograph was actually taken. Request you complete the attached FTD Form 164 and return it in the self-addressed envelope.
3. Due to a lapse of time in reporting your observation we may be unable to determine the stimulus which you observed since many official records are kept for a period of only thirty days.
