At 1145 hours on November 17, 1967, addition f Ucon, Idaho, reported to the USAEC that she had observed an unidentified flying object during the evening of November 16, 1967. Mrs. was traveling north on U. S. Highway 191 enroute to Rigby, Idaho, at the time. She stated her location was about one and one-half miles north of the Idaho State Police Port of Entry at Beeches Corner when this large, bright object came down from her right to about 30 feet off the highway and then disappeared over a field on her left. It seemed to have many green and blue lights on it.

It is our understanding that the U. S. Air Force has a compilation of reports on U.F.O. sightings, and it was determined to recontact Mrs. Cook to supplement this report for their information. Contact could not be established with her until 1908 hours on November 17, 1967. This conversation is reported in the form of questions and answers as follows:


