1. INTRO: THIS CABLE COVERS SELECTED EVENTS INVOLVING

"OFFICIAL" NEWS -- AND SOME NOT SO OFFICIAL

- 2. "AZERBAIJAN," THE OFFICIAL DAILY, JAN 19 PUBLISHED A STATEMENT BY SABIR RUSTAMXANLI, MINISTER OF PRESS AND INFORMATION. THE STATEMENT REMINDED "HEADS OF LOCAL EXECUTIVE AUTHORITIES AND ESTABLISHERS OF TV AND RADIO STATIONS" THAT EXISTING LAW PERMITS STATIONS TO GO ON THE AIR ONLY AFTER THEY REGISTER WITH THE PRESS MINISTRY AND OBTAIN THE PERMISSION OF THE MINISTRY OF COMMUNICATIONS; RUSTAMXANLI CRITICIZED PROVINCIAL SCATIONS WHICH BROADCAST WITHOUT SUCH PERMISSION. HE ADDED THAT THEIR PROGRAMS "ARE ON AN EXTREMELY LOW PROFESSIONAL LEVEL, ... SERVE THE INTERESTS OF VARIOUS GROUPS AND ARE OF NO ESTHETIC VALUE WHATSOEVER.... SERIOUS DISCONTENT IS CREATED AMONG PEOPLE, AND MORE COMPLAINTS ARE BEING SENT (TO THE MINISTRY). A MOVEMENT WHICH ONCE STARTED IN THE NAME OF DEMOCRACY AND FREEDOM OF SPEECH IS TAKING A DANGEROUS DIRECTION AND BECOMING AN IDEOLOGICAL PROVOCATION WHICH SHATTERS OUR SPIRITUAL FOUNDATIONS."
- 3. THE STATEMENT LISTED THE TV AND RADIO COMPANIES WHICH HAVE THE PERMISSION TO GO ON THE AIR. IRONICALLY, INCLUDED WAS B.M.TI, WHOSE TV BROADCASTS WERE SUSPENDED LAST SPRING ON THE PRETEXT THAT IT HAD VIOLATED ITS AGREEMENT WITH THE MINISTRY OF TELECOMMUNICATIONS AND WAS INDEBTED TO THE MINISTRY. THE ACTUAL REASON, AS EVERYONE KNEW, WAS THAT "GUNAY" NEWSPAPER, OWNED BY B.M.TI'S OWNER, HAD CRITICIZED THE SPEAKER OF THE AZERBAIJANI PARLIAMENT.
- 4. ONE OF THE COMPANIES ON THE "LEGAL" LIST, "XACMAS" TV IN THE NORTH-EASTERN TOWN OF AZERBAIJAN, WAS OBLIQUELY CRITICIZED IN THE MINISTER'S STATEMENT FOR WHAT MUST HAVE BEEN LEZGI NATIONALIST PROGRAMS. XACMAS HAS A CONSIDERABLE (IF NOT PREDOMINANT) ETHNIC LEZGI POPULATION, AND THE MINISTER'S STATEMENT ACCUSED THE STATION'S PROGRAMS OF "NOT HELPING STRENGTHEN THE FRIENDLY INTERETHNIC RELATIONS, BUT, ON THE CONTRARY, HEATING UP EMOTIONS..."
- 5. IN ANOTHER OFFICIAL HAPPENING, THE STATE TV AND RADIO COMPANY HELD A BOARD OF DIRECTORS MEETING, AT WHICH PRESIDENT BABAK HUSEYNOGLU REPORTED ON THE COMPANY'S 1994 PERFORMANCE. ACCORDING TO HUSEYNOGLU, OBVIOUS SHORTCOMINGS -- NOTHING SPECIFIC WAS REPORTED IN THE MEDIA -- WERE CAUSED NOT BY A LACK OF PROFESSIONALISM AMONG ITS EMPLOYEES OR THEIR ATTITUDE TO JOB, BUT BY TECHNICAL SHORTAGES.
- 6. MEANWHILE, "YEDDI GUN" (SEVEN DAYS), AN ANALYTICAL WEEKLY NEWS MAGAZINE ON AZERBAIJANI STATE TV, HAS BEEN GIVEN MORE PROMINENCE BY BEING MOVED FROM 10 P.M. TO IMMEDIATELY AFTER THE 8 P.M. NEWSCAST EACH SUNDAY. AS "AZERBAIJAN" DAILY GIVES OFFICIAL NEWS AND POLICY, "YEDDI GUN" SEEMS TO HAVE RECOME THE SOURCE FOR THE OFFICIAL

"SPIN."

7. "AZADLIQ" (LIBERTY), WHICH SUPPORTS THE OPPOSITION POPULAR FRONT, FEB 3 PUBLISHED A COPY OF AN AUTOBIOGRAPHY UNCLAS SECTION 02 OF 05 BAKU 000451

WRITTEN BY SALAHADDIN QULIYEV, ACTING CHIEF OF THE PRESIDENTIAL PRESS SERVICE, IN 1992 WHEN HE APPLIED FOR A POSITION AT A UN ION. QULIYEV WROTE THAT HE HAD LOST HIS PARENTS AS A CHILD AND HAD LIVED WITH HIS GRANDMOTHER "DURING THE PRESCHOOL PERIOD" OF HIS LIFE. INTRODUCING IT AS "GOOD NEWS FOR REVERED SALAHADDIN QULIYEV," AZADLIQ REPORTED THAT IT HAS "DISCOVERED" SALAHADDIN QULIYEV'S FATHER, MALIK QULIYEV, WHO IS DIRECTOR OF THE SCHOOL IN SALAHADDIN'S NATIVE VILLAGE. THE PAPER ADDED THAT ITS INFORMATION IS THAT THE FATHER WAS APPOINTED TO THE POSITION DUE TO THE SON'S DIRECT "ASSISTANCE."

ECONOMICS, TECHNICAL SHORTAGES AND NEW PAPERS

- 8. DUE TO THE SHORTAGE OF PRINTING MATERIALS AND TECHNICAL DIFFICULTIES, "AZERBAIJAN" STATE PUBLISHING HOUSE ANNOUNCED IT WOULD NOT PRINT NEW PAPERS AS OF JAN 15. THE PUBLISHER ALSO ANNOUNCED THAT IT WOULD STOP PUBLISHING NEWSPAPERS AND MAGAZINES WHOSE DEBT EXCEEDS 200 MILLION MANATS (ROUGHLY USD 45,000) BY FEB 1. "AZERBAIJAN" PUBLISHES 185 NEWSPAPERS AND MAGAZINES, AND ONLY 37 ARE NOT IN DEBT TO IT. AS OF FEB 3, ONLY ONE PAPER -- "MEYDAN" (SQUARE) OF THE NATIONAL STATEHOOD PARTY -- HAD PAID ITS DEBT. "AZERBAIJAN" HAS INFORMALLY EXTENDED THE DEADLINE WHILE MANY DEBTS ARE IN THE PROCESS OF BEING PAID THROUGH INTER-BANK TRANSFERS.
- 9. DESPITE ALL THE ECONOMIC AND TECHNICAL DIFFICULTIES WHICH HAVE FORCED PAPERS TO CUT BACK OR ALTOGETHER CEASE PUBLICATION, NEW PAPERS HAVE EMERGED. ONE OF THEM, "MIP" (THE AZERBAIJANI ACRONYM OF THE NATIONAL INDEPENDENCE PARTY), PUBLISHED ITS FIRST EDITION JAN 20. PARTY LEADER ETIBAR MAMMADOV HAD PUBLISHED A QUASI-PARTY PAPER, "MILLAT" (NATION). "MIP" WAS ANNOUNCED AS "THE ORGAN OF THE PARTY," WHICH LESSENS MILLAT'S CONNECTION TO THE PARTY

AND ALLOWS TO TAKE A MORE INDEPENDENT POSITION. "MIP" EDITOR-IN-CHIEF IS FIRIDUN CALILOV, SUPPORTER OF THE AZERBAIJANI POPULAR FRONT AND MINISTER OF EDUCATION IN THE APF GOVERNMENT, NOW A PROMINENT FIGURE IN THE NATIONAL INDEPENDENCE PARTY. PARTY MEMBERSHIP IS NECESSARY TO BE A "MIP" NEWSPAPER EMPLOYEE.

- 10. THE FIRST ISSUE OF "MAARIFCI" (ENLIGHTENER) (CIRCULATION 5,000) WAS PUBLISHED JAN 28. THE PRIVATE WEEKLY HAS AMONG ITS AIMS "TURNING ENLIGHTENMENT INTO AN ETHICAL, SPIRITUAL, CULTURAL AND POLITICAL PHENOMENON." CONGRATULATORY LETTERS FROM THE PRESIDENT OF THE ACADEMY OF SCIENCES, MINISTER OF CULTURE, GENERAL SECRETARY OF THE DEMOCRATIC ENLIGHTENMENT PARTY AND THE CHAIRMAN OF THE TEACHERS' UNION POINTED THE CLOSENESS OF THE PAPER'S AIMS TO THEIR OWN.
- 11. THE FIRST ISSUE OF "VESTNIK" (NEWSLETTER) OF AZERBAIJAN'S RUSSIAN COMMUNITY (CIRCULATION 6,600) WAS PUBLISHED JAN 27. THE WEEKLY WAS INTRODUCED AS A "SOURCE OF INFORMATIOM NOT ONLY FOR (ETHNIC) RUSSIANS BUT ALSO ABOUT (ETHNIC) RUSSIANS IN AZERBAIJAN." IT ALSO IS TO TELL READERS IN CIS ABOUT AZERBAIJAN AS WELL AS "PUBLISH ARTICLES ON HISTORIC ISSUES, PROPAGATE A HEALTHY WAY OF LIFE", HAVE A WOMEN'S CORNER, STORIES ABOUT UFO'S AND PARAPSYCHOLOGY, CARRY HOROSCOPES, ETC. THE PAPER IS UNCLAS SECTION 03 OF 05 BAKU 000451

THE MAGAZINE SAID IT SEES ITS AIM AS ESTABLISHING CLOSER CULTURAL TIES BETWEEN ETHNIC AZERIS AROUND THE WORLD; IT WILL ALSO BE DISTRIBUTED IN EUROPEAN COUNTRIES. SINCE THERE ARE MILLIONS OF ETHNIC AZERIS IN NORTHERN IRAN -- HENCE THE MAGAZINE'S NAME -- ITS PUBLISHERS (WHO INCLUDE A FORMER AZERBAIJANI AMBASSADOR TO IRAN) HOPE THAT "GUNEY AZERBAYCAN" WILL BE SOLD THERE. HOWEVER, THE MAGAZINE WAS

MET WITH CAUTION AT THE IRANIAN EMBASSY IN BAKU, WHICH ASKED FOR COPIES. THE GOI'S PERMISSION PRESUMABLY WOULD BE NECESSARY FOR SOUTH-OF-THE-BORDER DISTRIBUTION.

"SUBSCRIPTION CAMPAIGNS" AND MONOPOLIZED DISTRIBUTION

- 13. THE AZERBAIJANI OFFICIAL MEDIA HAVE PUBLISHED RESULTS OF "SUBSCRIPTION CAMPAIGNS" (A TERM INHERITED FROM THE DECADES OF THE SOVIET PERIOD WHEN EVERYONE FROM SCHOOL CHILDREN THROUGH MEMBERS OF THE COMMUNIST PARTY, WAS OBLIGED TO SUBSCRIBE TO APPROPRIATE PUBLICATIONS).

 ACCORDING TO NAZIM NOVRUZOV, CHIEF OF "AZERMATBUATYAYIM" (AZERBAIJANI PRINTED MEDIA DISTRIBUTION) PRODUCTION UNION, "AZERBAIJAN MUALLIMI" (AZERBAIJANI TEACHER), THE WEEKLY ORGAN OF THE MINISTRY OF EDUCATION, HAD THE BIGGEST NUMBER OF SUBSCRIBERS OBTAINED IN THIS WAY: 13,656 OF THE CIRCULATION OF 15,728. IT IS FOLLOWED BY "AZERBAIJAN," THE OFFICIAL DAILY (3,613 OF 26,282), "MUBARIZ KESIKDA" (ON GUARD) OF THE MINISTRY OF INTERNAL AFFAIRS (2,792 OF 13,003) AND "MADANIYYAT" (CULTURE) OF THE MINISTRY OF CULTURE (2,222, WHICH IS ALMOST ALL ITS CIRCULATION).
- 14. THE IMPRESSION FORMED BY THE REPORT THAT THESE MIGHT BE AMONG THE MOST POPULAR PUBLICATIONS IN AZERBAIJAN IS FALSE. THE MINISTRIES SIMPLY OBLIGED THEIR PERSONNEL TO SUBSCRIBE. MINISTER OF EDUCATION LIDIYA RASULOVA SIGNED ONE SUCH DECREE, WHICH WAS PUBLISHED IN "AZERBAIJAN MUALLIMI." THE "REQUEST" WAS ADDRESSED TO ALL THE MINISTRY'S VASSALS, STARTING WITH THE MINISTER OF EDUCATION OF THE NAXCIVAN AUTONOMOUS REPUBLIC DOWN TO HIGH SCHOOL DIRECTORS THROUGHOUT THE COUNTRY. - 16. IN ORDER TO GAIN SPONSORSHIP BY QASID, AZERBAIJANI RADIO AND TV GAVE IT THE EXCLUSIVE RIGHT TO NEGOTIATE PLACEMENT OF THE STATE TV AND RADIO PROGRAM SCHEDULES IN OTHER LOCAL, MEDIA. "QASID" WARNED THE AZERBAIJANI MEDIA THAT IT WOULD SUE ANY WHICH PRINTED UNAUTHORIZED AZTV PROGRAM SCHEDULES AND THREATENED TO STOP DISTRIBUTING THE "GUILTY" PAPERS. SINCE QASID HAS A QUASI-MONOPOLY ON THE DISTRIBUTION OF PRINTED MEDIA IN BAKU, THIS WAS NO IDLE THREAT.
- 17. "AYNA/ZERKALO" (SISTER WEEKLIES WHOSE NAME MEANS "MIRROR" IN AZERBAIJANI AND RUSSIAN) PROPOSED TO BUY THE PERMISSION FROM QASID, BUT THE ANSWER WAS NEGATIVE. WHEN AYNA/ZERKALO EDITOR RAUF TALISHINSKY ARGUED THAT THIS VIOLATED THE LAW ON MASS MEDIA, HE SAID AGAKISI ISMAYLOV, HEAD OF QASID, RESPONDED THAT THE SCHEDULES COULD BE REGARDED AS COMMERCIAL SECRETS.
- 18. QASID'S UNWILLINGNESS EVEN TO SELL THE LOGS TO OTHER MEDIA IS UNDERSTANDABLE, SINCE THIS LEAVES PEOPLE WITH NO CHOICE BUT TO BUY EKRAN-EFIR. ITS CIRCULATION TODAY HAS REACHED 120,000, WHICH IS UNPRECEDENTED IN AZERBAIJAN.
- 19. TALISHINSKY TOLD US QASID'S MONOPOLY CANNOT GO ON FOREVER: AYNA/ZERKALO IS DEVELOPING AN INDEPENDENT DISTRIBUTION SYSTEM WHICH ALREADY HANDLES MORE THAN A FIFTH OF THE TWO PAPERS' COMBINED CIRCULATION OF 32,000. AYNA/ZERKALO PLANS TO COMBINE ITS DISTRIBUTION SYSTEM WITH "YEDDI GUN" (SEVEN DAYS), ANOTHER WEEKLY. TALISHINSKY HAS NEGOTIATED WITH THE MINISTRY OF INTERNAL AFFAIRS TO MAKE SURE POLICE WILL NOT OPPOSE SALES IN THE STREETS AND IN METRO STATIONS. (STREET VENDORS ARE FORBIDDEN UNDER THE STATE OF EMERGENCY REGIME IN FORCE IN BAKU. HOWEVER, THE STREETS ARE FILLED WITH VENDORS.)

[Begin recording] [Diaz] Adolfo Zarate, a 74-year-old farmhand, was working in fields near the 127 km marker on the national highway at 2100 local time when he saw an oval object about the size of a compact car descend from the sky some 60 meters away from him. He watched the object for five minutes:

[Zarate] I then looked at the grass over here. It was not too clear; it was a bit dark where I was standing. I said: Man, I must be hallucinating. It went vroom and lifted off amid a shower of what looked like electrical sparks.

[Diaz] Torriente Police Chief Rafael Acosta confirmed the sighting to local station Radio Victoria de Giron.

[Acosta] I believe [words indistinct] able to find small traces there. They cannot be detected. We could not tell what had landed there.

[Correspondent] What traces? Traces in the grass?

[Acosta] Yes. It looked like the grass was frosted there.

[Correspondent] There was no scorched grass?

[Acosta] No, there was no scorched grass. Zarate has been telling us from the start that it took off amid a shower of sparks and that the noise it made was not that of a motor but more like

that of the wind.
