"Molester poses as alien to seduce teens"

(AP) Las Angeles - A convicted child molester got 20 years in prison for seducing two 13-year-old girls by telling them he was a space alien recruiting them for a utopian society in another galaxy.

Barry A. Briskman, 59, of suburban North Hollywood is already serving ten years in Nevada for using the same ruse to seduce a 12-year-old runaway, said Deputy District Attorney Steven J. Ipsen.

Briskman claimed to be an alien from the planet Cabell, recruiting girls for a female-dominated utopian society.

But first, he told the victims, they had to double their IQs and break down their "sub-cons," or subconscious intelligence barriers.

"It began with strip poker to break down our sub-cons," one victim

recalled. Later, she said, they had intercourse so he could inject the earth girls with "IRFs," immunities to ward off space diseases.

Another victim, now 18, called Briskman's actions "mental rape."

"I don't feel like I was the smartest of people for going along," the woman told Superior Court Judge Kathryn Ann Stoltz Friday before Stoltz sentenced Briskman. "He led me to believe many, many things. I wanted to believe them."

MFirst lady compares Whitewater probe with UFO fixation

WASHINGTON (AP) Hillary Rodham Clinton denied Thursday that administration officials tried to silence a key Whitewater figure and said the long investigation reminds her of ``some people's obsession with UFOs and the Hale-Bopp comet.''

President Clinton threw back his head and laughed when he heard about his wife's cosmic comparison. ``Did she say that?' he asked. ``That's pretty good.''

Publicly addressing the question of hush money for the first time, Mrs. Clinton rejected suggestions that White House officials hoped to discourage Webb Hubbell from talking to Whitewater investigators by helping him find work after he resigned from the Justice Department under an ethical cloud in 1994.

``There isn't anything to be hushed up,' she said on WAMU's ``Diane Rehm Show.''

Mrs. Clinton, who was a law partner of Hubbell's in Arkansas, said he was ``somebody who people wanted to help to get through what they thought was a rough patch in his life.''

Hubbell has acknowledged lying to President Clinton and telling him that there was no basis for charges against him. He later pleaded guilty to bilking his former law firm and its clients of hundreds of thousands of dollars and agreed to assist Whitewater prosecutors.

In recent interviews, Hubbell has said he is sorry for deceiving the Clintons, his longtime friends.

``I accept his apology,' Clinton said Thursday during a Cabinet Room photo session. ``I'm not angry at him anymore because he paid a very high price for the mistake he made.''

Mrs. Clinton, in her radio interview, said she hoped to meet with Hubbell at some point, but added that for now, ``if I were to see him, the conspiracy buffs would go wild and no telling what they would claim.''

Frustrated by Hubbell's memory lapses in the probe of the Clintons' finances, prosecutors are investigating whether the financial assistance he got after resigning was designed to improperly influence his cooperation.

``There's no evidence of that,' Mrs. Clinton said. ``There will not be any evidence of that.' The president last week said there was nothing improper in the effort to steer work to Hubbell, characterizing it as an act of compassion.

The first lady went on to dismiss the notion of hush money as ``part of the continuing saga of Whitewater, you know, the never-ending fictional conspiracy that, honest to goodness, reminds me of some people's obsession with UFOs and the Hale-Bopp comet

some days.'

Asked if she had any concern about being indicted, she said, ``None whatsoever.'

In her radio interview and a subsequent TV appearance on CNN, Mrs. Clinton also addressed questions about Democratic fund-raising abuses in last year's presidential campaign.

``Mistakes were made,' she told one radio caller who said his faith in the administration had been shaken. ``But I hope that you will follow this entire matter before you reach any conclusions.'

Asked about revelations that White House events were attended by felons, drug dealers and other questionable characters, Mrs. Clinton guessed that she has been photographed with perhaps a million people at various events and added, ``I do not know oftentimes who these people are. ... It's hard to know who to separate out and who not to.'

Echoing the words of her husband, Mrs. Clinton said the ``real issue is are we going to keep raising money like this for our political campaigns,' calling for campaign finance reforms.

Trying to project good humor despite persistent questioning about the Whitewater allegations, Mrs. Clinton batted away a suggestion from a CNN viewer that she run for office, saying, ``I'm considering a very long vacation when my husband's second term is over.'

CONGRESS DAILY reports a "forthcoming book by a former aide could cause some embarrassment" for Sen. Strom Thurmond (R-SC). Pocket Books is publishing retired Col. Philip Corso's book, "The Day After Roswell: A Former Pentagon Official Reveals the U.S. Government's Shocking UFO Cover-Up." The book argues that technology from the supposed UFO crash contributed to the development of computer chips, the laser and fiber optics. Its cover "trumpets Thurmond's complimentary foreword." A Thurmond aide said the author's request for a foreword "only described the book as Corso's personal memoirs and did not reveal its focus on aliens and UFOs." Corso, who worked for Thurmond in 60's and 70's "writes that as a Pentagon official in the early 1960s, he inherited a cabinet full of Roswell debris and eventually helped disseminate the pieces to defense contractors" (6/4).

BUFO nearly hit 747 near Philadelphia, Swissair says

ZURICH, Switzerland (AP) An unidentified, wingless object traveling at high speed passed dangerously close to a Swissair jetliner between Philadelphia and Boston, the airline said Friday.

The pilot and copilot gave U.S. investigators different descriptions of the object that passed about 50 yards from the Boeing 747 after it had taken off from Philadelphia on Aug. 9, said the airline.

The pilot told the U.S. National Transportation Safety Board that the object as long and wingless, but the copilot said it was more spherical, Swissair spokesman Erwin Schaerer said.

The incident took place at 23,000 feet. The plane's final destination was Zurich.
