[FBIS Translated Text] San Cristobal (SPECIAL) -- A large police and military mobilization took place over the weekend in Rubio, Junin Municipality, Tachira State, after a helicopter, presumably

Colombian, landed in the "Leonardo Alarcon" sports stadium. This caused great alarm among the city's residents.

Despite that both government and military authorities in Tachira were notified, no official information has yet been given to clarify the confusion, to the point that there has even been speculation that it could be "a UFO."

General (National Guard) Gerardo Briceno Garcia, chief of Regional Command No. 1, reported that the situation was being handled directly through the Ministry of Defense. He added that he could not provide exact information about the Colombian helicopter landing. According to witnesses in Rubio, "the pilot was lost because when he landed he asked if he was in the city of Cucuta."

Investigation Requested [subhead]

Tachira Deputy Walter Marquez said that the violation of Venezuelan air space and sovereignty represent a rather serious situation. He suggested that both civil aeronautics and military aviation from the Palo Alto and Santo Domingo air bases should offer information on the incident.

"Investigations should also take place on the circumstances in which these events took place, whether this was accidental or if there was an intentional violation to Venezuelan sovereignty. The same way a helicopter comes in unchallenged and without being noticed by our country's radar, anything could happen in the future and corrective measures should be taken," Marquez said.

The congressman insisted that he will request that an investigation be initiated with the Foreign Policy Commission to clarify the events in order to apply whatever corrective measures need to be taken.

YEARS OLD, ARE STILL FLYING AND PERFORMING VERY, VERY WELL. IN FACT B-52S WERE USED TO LAUNCH CRUISE MISSILES AGAINST TARGETS IN IRAQ SEVERAL MONTHS AGO. SO THEY'RE STILL VERY MUCH IN USE.

- Q: CAN B-2S LAUNCH CRUISE MISSILES?
- A: B-2S CAN LAUNCH A VARIETY OF ORDNANCE. I DON'T KNOW WHETHER THESE HAVE BEEN OUTFITTED TO LAUNCH CRUISE MISSILES.
- Q: WE HAVE IT FROM A HIGHLY RELIABLE SOURCE THAT THESE 13 B-2S ARE NOW IN MODIFICATION TO HAVE THEIR WINGS FOLDED AND OPERATE FROM CARRIERS. COULD YOU COMMENT ON THAT?
- A: SINCE THEY ARE A WING, I THINK IT WOULD BE HARD TO FOLD THE WING. IT WOULD BE LIKE FOLDING A BUTTERFLY.
- Q: THE MASS SUICIDE IN CALIFORNIA HAS AROUSED THE AMERICAN PUBLIC'S GROWING INTEREST ONCE AGAIN IN UFOS TO THE POINT WHERE SOME OF THE PUBLIC BELIEVES THAT THE GOVERNMENT CAN SUBSTANTIATE THEIR EXISTENCE--THAT THE GOVERNMENT HOUSES REMAINS OF THESE SPACECRAFT AND ALIENS. - Q: WHEN CITIZENS CALL WITH SIGHTINGS OF UFOS, WHERE ARE THOSE CALLS ROUTED TO NOW?
- A: THAT'S AN INTERESTING QUESTION. LET ME TALK A LITTLE BIT ABOUT UFOS.

FOR 22 YEARS, FROM 1947 TO 1969, THE U.S. AIR FORCE INVESTIGATED REPORTS OF UFOS. IT WAS CALLED PROJECT BLUE BOOK, AND THAT PROJECT WAS HEADQUARTERED AT WRIGHT-PATTERSON AIR FORCE BASE IN DAYTON, OHIO. THEY INVESTIGATED 12,618 SIGHTINGS DURING THAT 22-YEAR PERIOD, AND THEY REACHED THREE CONCLUSIONS BASED ON THOSE INVESTIGATIONS.

THE FIRST WAS THAT NO UFO REPORTED, INVESTIGATED OR EVALUATED BY THE U.S. AIR FORCE POSED ANY THREAT TO UNITED STATES OF AMERICA NATIONAL SECURITY. THAT WAS THE FIRST CONCLUSION THEY REACHED.

THE SECOND CONCLUSION THEY REACHED WAS THAT THERE WAS NO EVIDENCE SUBMITTED TO THE AIR FORCE OR UNCOVERED BY THE AIR FORCE THAT SIGHTINGS CALLED "UNIDENTIFIED" REPRESENTED TECHNOLOGICAL

DEVELOPMENTS OR PRINCIPLES BEYOND THE RANGE OF OUR SCIENTIFIC KNOWLEDGE. IN OTHER WORDS, THERE WAS NOTHING OUTSIDE THE REALM UNCLAS SECTION 03 OF 05
OF OUR SCIENTIFIC KNOWLEDGE, OUR ABILITY TO BUILD AIRCRAFT, UNDERSTAND AIRCRAFT, ETC.

THOSE ARE THE ONES THAT I REFERRED TO IN THE SECOND POINT I WAS MAKING, WHICH IS, OF THE SIGHTINGS IDENTIFIED OR CATEGORIZED AS UNIDENTIFIED. NOTHING REPRESENTED TECHNOLOGICAL DEVELOPMENTS BEYOND THE REALM OF OUR KNOWLEDGE.

SO MANY OF THESE WE BELIEVE MIGHT HAVE JUST BEEN SKETCHY REPORTS THAT COULDN'T BE TRACKED DOWN TOTALLY; THEY COULDN'T BE

O: SO THE CALLS ARE ROUTED TO WHERE NOW?

A: NOW THE CALLS ARE ROUTED TO PRIVATE ORGANIZATIONS. THERE ARE A NUMBER OF PRIVATE ORGANIZATIONS THAT LOOK INTO UFOS. YOU CAN GET THESE NAMES OFF THE INTERNET IF YOU ENTER UFO YOU CAN GET NAMES OFF THE INTERNET. AS YOU KNOW, WE HAVE A PROGRAM--THE COOPERATIVE THREAT REDUCTION PROGRAM--THAT IS HELPING RUSSIA DESTROY ITS NUCLEAR ARSENALS. IT HELPS THEM CUT THE WINGS OFF BOMBERS; IT HELPS THEM DISMANTLE MISSILES. WE PROVIDE ALL OF THAT ASSISTANCE IN KIND TO UNCLAS SECTION 04 OF 05

RUSSIA. NOT IN TERMS OF MONEY. WE PROVIDE THEM EQUIPMENT, WE PROVIDE THEM TECHNOLOGICAL ADVICE, TECHNICAL ASSISTANCE, ETC. SO THESE ARE ENTIRELY DIFFERENT PROGRAMS AND IT'S NOT, THEY CAN'T TAKE MONEY FROM THE COOPERATIVE THREAT REDUCTION PROGRAM, ALSO KNOWN AS NUNN/LUGAR, AND DIVERT IT TO OTHER PURPOSES.

IT CARRIES GOODS FOR THE WORLD'S LARGEST, MOST POPULOUS COUNTRY; A COUNTRY THAT HAS BEEN EXPERIENCING ECONOMIC BOOM AND DOING MORE AND MORE TRADING ALL OVER THE WORLD, INCLUDING WITH THE UNITED STATES. IT IS THE COMPANY THAT BRINGS CHINESE GOODS, ONE OF THE COMPANIES THAT BRINGS CHINESE GOODS TO THE UNITED STATES, AND THEN CARRIES U.S. GOODS BACK TO [CHINA]. I KNOW THAT YOU PROBABLY SPENT ENOUGH TIME IN SOUTHERN CALIFORNIA TO HAVE SEEN COSCO CONTAINERS TRAVELING ON TRUCKS OR RAILROAD TRAINS. Rodriguez says he has learned there is evidence of the presence of UFO's in the world, but the explosion of a UFO in New Mexico in 1947 and the results of an autopsy performed on one of the humanoid bodies found at the site has been kept a secret by the Americans.

Almeida adds: "There is a double standard by the US Government. On the one hand they discredit and ridicule the topic, but, on the other, they have commissions working on a government budget to conduct the investigations. It is an opportunity for them to have access to new technology, a contribution to their economy, of

course."

(Slachter) adds that it may be possible that extraterrestrials did in fact land and that the Americans kept all the secrets for themselves, but he says there could be a second part to the story: "The extraterrestrials came here, but the Americans took advantage of this to stage a great disinformation campaign on a global level. Based on that reality, they could have implemented a giant disinformation campaign to conduct experiments in the world, always saying: these are not our systems, they come from outer space, they are extraterrestrials. That could be a possibility."

Osvaldo Rodriguez adds: "I want to point out that, last year, there was a great commotion after a peasant in southern Matanzas Province claimed he saw a flying saucer land in an area near him. He claims to have seen two human-looking beings. It was a story carried by our television and our media. We have also been visited by strange objects; however, we may wonder: could this not be part of the US aggression against Cuba? Could they be testing our defense systems? Christian was telling me that people who have seen these objects claim they hear no sound. We know the United States has planes that are not detected by radar. Could this not be part of the war against us?"

Almedia goes on to explain that 50 years have passed since the UFO incident in New Mexico. He says a CD-ROM is now available with over 1,700 declassified documents of the US Government on the subject. It is not that the United States is being nice and wants the world to be informed about it, but it is because there is a series of civilian institutions that are exerting pressure for this information to be made available. Almeida adds that inexplicable technological advances are taking place. "These advances can only be explained by a technological transfer, of which the Americans are taking advantage to maintain their policy of world domination."

Almeida says the UFO topic is being manipulated because of the way it has been handled by the US Government. "It is information blockade, which prevents the information from being made available to other countries. The United States maintains a direct blockade against Cuba, but is also maintaining a blockade on the rest of the world, which does not permit us to draw our own conclusions on the matter. They want to impose their reasons and their truth," Almeida concludes.
